## **SPECIFICATIONS**

#### 1. SCOPE

- 1.1. It is the intent and purpose of this solicitation to establish a 60 month close end lease (True Lease) to provide for the lease of a Land Mobile Radio (LMR) system (Radio's {82} and Infrastructure) for special use by Rockland County Sheriff Corrections Facility to provide radio coverage for at least 90% of the corrections facility. System and infrastructure shall be new unused equipment since current equipment shall be returned to current awardee.
- 1.2. This lease shall be for a complete radio communications solution, supply, installation, programming and all maintenance.
- 1.3. System Specifications:
  - 1.3.1. The vendor shall provide a minimum of 1 digital talk path for operations as well as a 2<sup>nd</sup> digital talk path for supervisors. There may also be a 3<sup>rd</sup> path for additional administration.
  - 1.3.2. This bid is for full replacement of the existing radio system. The vendor must provide a proposed cut over schedule that allows for no down time of the system. This shall be a "hot cut over". The awarded firm shall co-ordinate with current firm in the removal of the current system.
  - 1.3.3. Provide Unit ID and Man Down alarming capabilities for all subscribers. The existing Man Down alarming system must be interfaced with the new radio system.
  - 1.3.4. Awarded firm shall be responsible for a fully Managed Service program. Awarded firm shall have ample spares to provide immediate replacement / swap of inoperable radio's. Bid response shall indicate how firm shall handle inoperable radio's (provide extra on-site, etc.). Awarded firm shall respond to any on-site Control / Repeater System Infrastructure repairs within four (4) hours of request.

#### 2. PRICE

- 2.1. The monthly price is based on a firm fixed sixty (60) month lease, F.O.B. <u>any point</u> in Rockland County, NY. Price includes all duties, taxes, charges, installation, inspection, servicing / maintaining of equipment/system, etc.
- 2.2. Continuation of the lease for each additional year after the first shall be subject to the availability of funds. Non-continuation of funding will not be considered as early termination of lease.

#### 3. EARLY TERMINATION OF LEASE

3.1. In the event of early termination of the lease, the lessee may be responsible for the payment of additional fees in accordance with contractor's standard fee schedule subject to the approval of the Director of Purchasing.

- 4.3. Delivery shall be made in accordance with instructions on Purchase Order. If there is a discrepancy between the purchase order and what is listed on the contract, it is the contractor's obligation to seek clarification from the Director of Purchasing.
- 4.4. <u>Delivery Condition</u> Equipment must be delivered strictly in accordance with specifications and shall be "Ready for Use", and/or as requested by the purchaser. If equipment is delivered with deviations or improper servicing, the contractor must arrange to have the necessary work done within five (5) days (exclusive of Saturdays, Sundays, and holidays) after receipt of written notification from the agency and/or the Director of Purchasing. Otherwise, the purchasing agency may have the corrections made at contractor's expense.
- 4.5. <u>Delivery Certification</u> Contractor shall secure a signed receipt from agency certifying to delivery of equipment. In the event deficiencies are later noted and a properly signed receipt is not available, contractor will be responsible.
- 4.6. Each lease shall be for the term of sixty (60) months from the time that the equipment is delivered and accepted.
- 4.7. Vendor shall provide early termination requirements in writing. (See para. 3.1)
- 4.8. Equipment types shall be as specified or an approved equal

#### 5. EQUIPMENT LEASE BILLING AND PAYMENTS

- 5.1. Upon the submission of invoices or vouchers, the entity shall pay for each item at the rate(s) contracted for as a result of this bid solicitation. Invoice shall be mailed by the Contractor to the individual entity indicated on each delivery order.
- 5.2. Payment shall accrue from the date each item is delivered to and accepted by the entity, and shall continue until the expiration of the contract term or the termination of this contract. However, payment shall accrue only for the period that the equipment is in the possession of the entity.

- 5.3. Payment shall not accrue for any equipment that the entity determines does not comply with the terms and conditions of the contract, until such time as the requirement of this solicitation are met, or the equipment is replaced or the defect is corrected.
- 5.4. Payment stated in monthly terms shall be prorated on the basis of 1/30th of the monthly rate for each day the equipment is in the entity's possession.
- 5.5. The charges against the contract will be paid by the requiring facility on a monthly basis upon the receipt of a monthly invoice showing (1) equipment number (or identification number); (2) facility delivery order number, and (3) the month for which each charge contained on the invoice is applicable. The initial invoice must contain the date of the delivery for that equipment.

#### 6. LOSS DAMAGE

- 6.1. The entity shall be responsible for loss of or damage to equipment, except for (i) normal wear and tear and (ii) loss or damage caused by negligence of the contractor, its agents, or employees; and (iii) product defects.
- 6.2. In the event equipment becomes lost, stolen and not recovered, damaged or destroyed beyond repair, Lessee shall pay Lessor the current depreciated value of such equipment as established by Lessor provided that the depreciated value is determined by using a method at least as favorable as the double declining-balance method, plus any outstanding fees or charges including the monthly lease fee for the applicable month in which equipment is rendered unserviceable, minus any insurance proceeds Lessor receives from Lessee's insurance carrier. In no event shall the amount due exceed the sale price of the equipment.

#### 7. RETURN OF EQUIPMENT

- 7.1. At least thirty (30) days prior to the expiration or termination of the leasing agreement entered into by pursuant to the established contract, the lessee will contact the lessor to arrange for the contractor to pick-up equipment. There shall be no expense relating to the turn-in of equipment by the County.
- 7.2. Equipment will be released to the Contractor for this inspection no later than five (5) days after termination or expiration of the lease for that equipment. The lessee will be required to surrender the equipment to the contractor either by delivering to the lessor or having the lessor pick up at the lessee's location no later than ten (10) calendar days after the termination of the lease. Failure of contractor to pickup equipment within stated days, no additional lease payments will be granted.

#### 8. ACCIDENTS/THEFTS/VANDALISM

8.1. The lessee will notify the Contractor within three (3) business days of accident/theft/vandalism and will arrange for repairs of accident/vandalism damage, including damage sustained to stolen equipment during the period prior to recovery. The Contractor will not be required to provide replacement equipment during the period the equipment is out of service.

8.2. If the equipment is damaged beyond repair or not recovered thirty (30) days after the date of theft, the Contractor will be reimbursed the residual value of the equipment based on the average of the wholesale and retail price at the time of the theft/accident/vandalism in full satisfaction of any and all liabilities under the contract, provided that the entity's liability to pay the monthly cost shall cease as of the time of the accident/theft/vandalism. The accrued lease cost for the month in which the accident/theft/vandalism occurs shall be determined on a pro-rata monthly basis. The Contractor shall provide the lessee documentation relating to all monies received from the salvage or other disposition of such equipment.

## A. Criminal Background Check

B. All personnel entering the correctional facilities are subject to security / criminal history check. To accomplish this, the Contractor must provide the County with the following information on each personnel who will provide on-site services:

- C. The county requires an assignment of the Contractor's personnel to be a permanent group of employees to avoid security problems.
- D. If the County determines that for security reasons, any personnel are unacceptable, the Contractor will act immediately to provide an acceptable replacement at no additional cost to the County.
- E. The County will require all contractor employees delivering services within the facility to wear a uniform. The uniform will be immediately recognizable as a contractor's employee and must be worn at all times. All contractor employees will display an identification card at all times while in the facility.
- F. The County reserves the right to refuse access to any person wearing inappropriate attire. The Correctional Center is a professional work environment and should be treated as such.
- G. In addition, any Subcontractor and their subsequent staff must also pass a background check as described above.
