2. Any other political subdivision or Rockland County non profit agency will issue purchase orders directly to vendors within the specified contract period referencing the County's contract and must be liable for any payments due on such purchase orders; and must accept sole responsibility for any payment due.
3. All purchases must be subject to audit and inspection by the other political subdivisions and Rockland County non profit agencies for which the purchase was made.
4. No officer, board or agency of a county, town, village, or school district must make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders must be on notice that as a condition of the award of a County contract, the successful bidder must accept the award of a similar contract with any other political subdivision in New York State and Rockland County non profit agencies authorized to use New York State's contracts, if called upon to do so. A listing of approved Rockland County non profit agencies is available on the Purchasing Division's website at www.rcpurchasing.com. The County, however, will not be responsible for any debts incurred by the participants pursuant to this or any other agreement.
6. Necessary deviations from the County's specifications in the award of a participant contract, whether such deviations relate to quantities, or delivery points must be resolved between the successful bidder and the other political subdivisions and Rockland County non profit agencies.

SPECIFICATIONS

1. SCOPE

- 1.1. This bid is to provide pricing for replacement parts for Carter Pumps as required by the County of Rockland.
- 1.2. Parts will be ordered on an as needed basis.
 - 1.2.1. This bid does not cover the purchase of new pumps.

2. REQUIREMENTS

- 2.1. This bid is to include all Carter pump parts for the various pumps utilized by the County of Rockland Sewer District #1 (RCSD).
- 2.2. Rockland County Sewer District #1 (RCSD) reserves the right to add or eliminate any model of Carter pump during the term of this contract, however, the following is a list of the current models operated at RCSD locations.

2.3. CARTER DUPLEX PUMPS

- **Model 801H**

- 2.4. This bid includes sub-assemblies, i.e. rotating assemblies and castings.
- 2.5. The County of Rockland reserves the right to bid or obtain additional pricing should such procedures result in the benefit of the County of Rockland.
- 2.6. Items must be manufactured by Carter or approved equal.

3. APPROVED EQUAL OR EQUIVALENT PRODUCTS

- 3.1. Bidders must submit an item by item listing and explanation of any differences between their product specifications and performance and the listed bid specifications. Product and service warranties must be included with bid.
- 3.2. If bidders submit or bid for equivalent or approved equal products, they must submit manufacturer's product description and specifications. These specifications must include all items listed in the bid specifications.
- 3.3. Bidders must list five entities currently using the product on the certification of experience page in the bid package. The items must be used on listed Carter pump. Items requiring adapters will not be acceptable.
- 3.4. Bidder must be able to demonstrate within one week after notice and guarantee in writing that the item bid is interconnectable with existing equipment.

- 4.1. Bidder must submit unit pricing for rotating assemblies and itemized parts for the specified pump.
- 4.1.1. Unit Pricing must include FOB Destination.
- 4.2. Additionally, bidder must submit two pricing structures for each Section that provide a percentage discount based on the official manufacturer's published retail price list.
- 4.2.1. Pricing Structure #1 - The percentage discount for materials / parts ordered under this section must include *FOB Destination, Freight Prepaid and Added*. The seller pays the freight charges but bills them to the customer. The seller owns the goods while they are in transit and files any claim if necessary. Title passes at the buyer's location.
- 4.2.2. Pricing Structure #2 - The percentage discount for materials / parts ordered under this section must include *FOB Destination, Freight Prepaid and Allowed*. The seller pays and bears the freight charges and owns the goods while they are in transit. Title passes at the buyer's location.
- 4.2.3. ORDERS - The contractor must submit a price quote for items ordered under this section. The price quote must contain pricing under Structure #1 and Structure #2 at the time of quote. At the time of order, the Department Authorized Representative must determine which pricing structure best suits the need of the County of Rockland.
- 4.3. Price list must be the current manufacturer's retail price list at the time of bidding and as up-dated by the manufacturer during the life of the contract. Vendor must submit number and date of catalogs used.
- 4.4. Contractor must provide the County of Rockland with manufacturer's current catalog and price list within three (3) days from date of request or submit/upload with the bid proposal.

5. MATERIAL COST

- 5.1. The invoices for payment must list specifically all parts and materials and the current MFG. List Price for each item listed less the awarded % discount.
- 5.1.1. Documentation of the current MFG's list price for replacement parts costing greater than \$100 must be provided with Contractor's invoices.

6. DELIVERY

- 6.1. For items in stock at the vendor's place of business, delivery must be made immediately after receipt of order by the vendor.
- 6.2. For items not in stock, the vendor must make delivery immediately after his receipt of the parts from the manufacturer.
- 6.3. All deliveries must be made during the hours of 8:00AM to 2:00PM to the location specified on the Purchase Order.

7. AWARD

- 7.1. This bid must be awarded by to the lowest responsive, responsible bidder meeting the stated requirements.
