3. All purchases shall be subject to audit and inspection by the other political subdivisions and Rockland County non profit agencies for which the purchase was made.
4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non profit agencies authorized to use New York State's contracts, if called upon to do so. A listing of approved Rockland County non profit agencies is available on the Purchasing Division's website at www.rcpurchasing.com. The County, however, will not be responsible for any debts incurred by the participants pursuant to this or any other agreement.

1. SCOPE

- 4.1. Items will be evaluated on the basis of Manufacturer's automated published price lists. Manufacturer's price lists are to be currently Published Manufacturer's Price Lists (Retail, Dealer, or Jobber or their equivalent). Bidder shall bid the percentage discount from one of the Published Manufacturer's Price List cited above and shall provide a copy (see paragraph 4.5) of same with bid submission and clearly identify the column and product line to which the discount applies. Discounts must be stated as a single percentage.
- 4.2. Unless the bidder takes specific exception, any terms and conditions contained in the parts price list(s) submitted will not take precedence over the terms and conditions specified herein.
- 4.3. Upon request, the Contractor is to provide copies of manufacturer's product catalogs.

5. OPTION TO EXTEND

- 5.1. The County of Rockland and vendor, upon mutual agreement, shall extend the period of this agreement up to two additional years in one- year increments.

6. EMERGENCY PURCHASES

- 6.1. The County of Rockland reserves the right to purchase from other sources, those items which are required on an emergency pick-up basis and cannot be supplied immediately from stock by the Contractor.
- 6.2. The County of Rockland may authorize the contractor to expedite delivery of critical parts (FOB shipping point) through air freight, UPS, transit bus or other, on an exception basis. The cost of shipping will be borne by the County.

7. PARTS EXCHANGE

- 7.1. Supplier expressly agrees to exchange at no cost (at time of exchange) all unused parts purchased either prior to or during the contract. Parts to be exchanged will be those parts, which have become obsolete to the County of Rockland. The County of Rockland will be the sole judge of obsolescence. Parts returned shall be in their original packaging.
- 7.2. DEFECTIVE PRODUCT: All defective products shall be replaced and exchanged by the Contractor. The cost of transportation, unpacking, inspection, re-packing, re-shipping or other like expenses shall be paid by the Contractor. All replacement products must be received by the County within 7 days of initial notification.

8. BACK ORDERS

- 8.1. All back orders must have the prior approval of the County of Rockland representative placing the order. The County of Rockland will not accept delivery of back orders without this prior approval to back order.

9. STOCK AVAILABILITY AND DELIVERY OF PARTS (PERFORMANCE REQUIREMENT)

- 9.1. Contractor shall establish and maintain sufficient local parts inventory to adequately support the County of Rockland's fleet of vehicles and equipment. Daily delivery required Monday through Friday.

10. SPECIAL CONDITIONS

- 10.1. The New "Hazardous Communications" and "Right to Know" laws require certain chemicals, cleaners, paints, etc. to be delivered with "Material Safety Data Sheets" and be labeled accordingly. The contract vendor shall guarantee that all State and/or EPA Hazardous Materials Regulations are met where applicable.
- 10.2. All filters must be of the non-template type. If filters containing template are the only available product, the County of Rockland must be notified prior to the purchase and reserves the right to accept or decline the product being offered.

 - 11.1.6. Name of County Agency receiving the supplies.
 - 11.1.7. All invoices/Delivery Receipts must show the part numbers and parts discount.
- 11.2. In all instances, the Contractor's sales/delivery ticket will be prepared in duplicate, whether delivery is made by the Contractor or pick up is made by the authorized representative of the County at the Contractor's place of business.
