# **SPECIFICATIONS**

#### 1. SCOPE

1.1. This Bid is for the purpose of providing Genetic Parentage Testing Services for the County of Rockland Department of Social Services and other County of Rockland Departments needing such services.

## 2. REQUIREMENTS

- 2.1. Bidder must perform work in conformance with all Federal, State and Laws and Regulations.
  - 2.1.1. Bidder must perform all work in conformance with all New York State Department of Health and HIPAA regulations.
    - 2.1.1.1.Laboratory shall be approved by New York State Department of Health (NYSDOH) to perform legally and medically acceptable genetic testing, to comply with New York State Family Court Act, Section 532 and 542, CPLR Section 4518 and 18NYSCRR 347.6.
  - 2.1.2. Laboratory must provide a copy of their NY State Department of Health Permit
- 2.2. The Contractor must provide documentation that its laboratory has received the accreditation of the American Association of Blood banks or the American Society for Histocompatability and Immuogenetics.
  - 2.2.1. The Contractor must maintain such accreditation through the life of the contract.
  - 2.2.2. The Contractor agrees to perform only those genetic tests, which are acknowledged as reliable by the American Association of Blood banks or the American Society for Histocompatability and Immuogenetics.
  - 2.2.3. The Contractor agrees to perform such tests in order that the results can be admitted as evidence of paternity without the need for additional foundation testimony or other proof of accuracy.
- 2.3. Bidder must have a minimum of three (3) years' experience in performing Genetic Parentage Testing Services.
- 2.4. Bidder must provide their Laboratory's Standard Chain-of-Custody Procedures.
- 2.5. Specimen Collection must be provided at a mutually agreed location.
- 2.6. Laboratory must provide all supplies necessary for the collection, preparation and preservation of all specimens to be submitted to the Laboratory for testing.

- 2.7. Laboratory staff must be available to consult with County by telephone during normal Laboratory working hours to discuss Laboratory's procedures and explain test results.
- 2.8. The County of Rockland Department of Social Services requested approximately 80 tests in 2019, the total number of tests decreased due to COVID-19 in 2020 and 2021. It is anticipated an estimate of 200 tests will be required annually.
- 2.9. The current frequency of the collection is every other Tuesday at the Rockland County Family Court from 9am to 12:30 pm. The majority of these collections occur at the Rockland County Courthouse located in New City, NY 10956. The Vendor will be required at times to arrange to take specimens on parties that are incarcerated or reside outside of Rockland County (these types of collections occur about twenty times a year). The frequency of collections at the Rockland County Courthouse and day of service could change at any time based on the needs of the County of Rockland. These services will need to be provided at other times and locations on an as needed basis, when requested by the County of Rockland Department of Social Services.

## 3. GENETIC MARKER TESTING

- 3.1. Testing shall have the power to exclude more than 99.9% of randomly selected males or probability of paternity greater than 99% in all cases where the alleged Father is not excluded from paternity.
- 3.2. Primary Test Battery must consist of multiple independent DNA Genetic Systems.
  - 3.2.1. Genetic Testing Marker Test must be price per person and must include cases involving Deceased Parties and Mother-not Tested Cases (Motherless Calculations).
- 3.3. Test results must reflect exclusions in at least three (3) independent genetic systems or a probability of paternity greater than 99% in each case.

#### 4. **REPORTING**

- 4.1. Upon completion of Test Battery ordered, an evaluation of the test results must be performed by the Director of Laboratory.
  - 4.1.1. The Case must be finalized and Final Report issued if the following:
    - 4.1.1.1. The Alleged Father is excluded from Paternity in at least two (2) independent Genetic Marker Systems or the Alleged Father is not excluded from Paternity and the probability of Paternity is equal to or greater than 99%.
    - 4.1.1.2. If neither conditions in 4.1.1.1. are realized, additional testing must be performed until one of these conditions are met. All Testing Cost must be included in price for DNA Test Battery.

## 5. TESTIMONY

- 5.1. Laboratory may be required to provide expert Testimonial and Witness Services with respect to Specimens tested under this bid when requested by the County of Rockland Department of Social Services account, which requested these services.
  - 5.1.1. Expert Testimonial and Witness Services must be included in the Genetic Marker Test price.
- 5.2. County of Rockland Department of Social Services account, which requested these services, shall provide two week notice for scheduling an expert to appear.

#### 6. BILLING

- 6.1. Contractor must bill on a monthly basis for these services.
  - 6.1.1. Billing must include but, not limited to, the following:
    - a) Identify Individuals to whom services are provided.
    - b) Clearly itemize the cost per individual as per bid.

#### 7. AWARD

7.1. Bid will be awarded to the lowest responsible bidder. Quantities listed on bid submission forms are estimates. Actual quantities required may be greater or less than estimated quantities.
