3. All purchases shall be subject to audit and inspection by the other political subdivisions and Rockland County non profit agencies for which the purchase was made.
4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non profit agencies authorized to use New York State's contracts, if called upon to do so. The County, however, will not be responsible for any debts incurred by the participants pursuant to this or any other agreement.

SPECIFICATIONS

1. SCOPE

- 1.1. Provide pricing to furnish and deliver specified replacement parts for the specified Dry-Pit Sewage Pumps Mfg. by Morris Pumps. Replacement parts are to be of equal or better quality than the original OEM parts. Replacement parts shall not require adaptors, spacers or any adjustments in order to fit.

2. APPROVED EQUAL OR EQUIVALENT ITEMS

- 2.1. Bidder shall submit with bid a list of five locations where the offered replacement parts for the specified pumps are being used. Include – pump model, equipment it's being used with, location, contact, contact telephone number, and amount of years in service.
- 2.2. Bidder must submit all testing and rating results with bid.
- 2.3. Bidder must guarantee in writing with their bid and be able to demonstrate within one-week notice the interconnectability of their equipment with the existing equipment.
- 2.4. Bidder must complete the Certificate of Experience. Bidder to list a minimum of three agencies where same or similar products have been supplied over the past three (3) years.

3. PRICE

3.1. Pricing for specified parts to be FOB Destination.

3.1.1. Unit pricing shall be provided for the items listed on the proposal pages.

3.1.2. Bidder shall submit a percent discount off of the official manufacturer's published retail price list for replacement parts and /or fabrication costs for items not specifically listed.

3.1.2.1. The percent discount offered shall also be applied to any quote received for the fabrication of required parts.

3.1.3. The price bid shall be in the form of a percent discount from manufacturer's suggested retail list price. Suggested retail list price shall be defined as that published in their latest standard printed price list. Bidders shall enter, in the space provided on the proposal pages, the applicable discount which shall remain firm for the life of the contract.

3.1.3.1. Industry wide increases, as reflected in newly published manufacturer's price listings will be honored.

3.1.3.2. In as much as the price list in the possession of the Division of Purchasing shall be the governing copy, it shall be the responsibility of the successful bidder to ensure that the current price sheets are forwarded to the Division of Purchasing.

3.1.3.3. Under the authority of any resultant award hereto, the County of Rockland specifically reserves the right to award any such additional items as may be required for its operations.

3.1.3.4. Successful bidder must supply pricing structure where % discount will be applicable, catalog and/or URL address.

3.1.3.5. Price increases will not be allowed, unless the Division of Purchasing is in possession of the current price sheets.

3.1.3.6. All discounts shall be firm and fixed for the specified contract period.

3.1.3.7. Offers containing chain or multiple discounts may be considered non-responsive.

4. MATERIAL COST

4.1. The invoices for payment must list specifically all parts and materials and the current MFG. List Price or Quote provided for fabricated parts for each item listed less the awarded % discount.

4.1.1. Documentation of the current MFG's list price or quote for replacement parts costing greater than \$100 must be provided with Contractor's invoices.

5. PRICE ADJUSTMENT

- 5.1. The County recognizes this product or service has a price component that may have a commodity with changing costs. The Contractor/Supplier may request a Price Adjustment no more frequently than once each quarter (3 month period).

A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (ie, commodity increases), the current pricing, and the requested revised pricing.

The County will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County will provide a written explanation in support of the decision.

The Director of Purchasing may use available indexes (e.g. CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that exceeds 5% will not be approved unless very unusual and significant changes have occurred in the industry.

In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices/pricing that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation.

6. DELIVERY

- 6.1. For items in stock at the vendor's place of business, delivery shall be made immediately after receipt of order by the vendor.
- 6.2. For items not in stock, the vendor shall make delivery immediately after his receipt of the parts from the manufacturer.
- 6.3. All deliveries shall be made during the hours of 8:00AM to 2:00PM to the location specified on the Purchase Order.

7. AWARD

- 7.1. Award shall be made to the lowest responsive responsible bidder meeting the stated requirements.
- 7.1.1. The County reserves the right to award this contract on a line by line basis to the lowest responsive responsible bidder or bidders.
