At no time shall the ESCO pass through any additional cost to the customer for this fee.

#### 7. PRICING REQUIREMENTS FOR INTERRUPTIBLE NATURAL GAS

- 7.1 This is a cooperative IT Natural Gas purchase. The County is seeking one (1) aggregate price for both agencies, for each pricing option requested.
- 7.2 This is an interruptible gas purchase; the flow start date for all accounts will be the meter read on or after December 31, 2022.
- 7.3 The County is seeking NYMEX + Basis pricing to the City Gate for the requested terms.
- 7.4 The County requests IT Natural Gas Bids for the following terms: six (6) months, twelve (12) months, and eighteen (18) months.
- 7.5 The County requests pricing for 100% Swing Tolerances for all requested pricing terms.
- 7.6 Pricing shall be stated for IT Natural Gas supply service only.
- 7.7 **Pricing Option 1** must be based on a city gate rate per dekatherm, including any Orange & Rockland Utility line loss charges to the city gate and 100% Swing Tolerance 6 month term.
- 7.8 **Pricing Option 2** must be based on city gate rate per dekatherm, including any Orange & Rockland Utility line loss charges to the city gate and 100% Swing Tolerance- 12 month term.
- 7.9 **Pricing Option 3** must be based on city gate rate per dekatherm, including any Orange & Rockland Utility line loss charges to the city gate and 100% Swing Tolerance- 18 month term.

7.10 Grossing of volumes to account for any losses to the city gate is strictly prohibited.

- 7.11 All NYMEX + Basis pricing must include a "trigger option" permitting the customer to lock in a fixed NYMEX natural gas rate at any time during the service term.
- 7.12 Each agency shall contract and be billed separately for its IT Natural Gas supply.
- 7.13 Billing method is Dual Bill.
- 7.14 Payment terms are **Net 20**.
- 7.15 The ESCO shall obtain the latest account and usage information directly from Orange & Rockland Utility to develop its bid. Should any accounts be identified that are not included in the account list, the ESCO shall identify those accounts as additional accounts in its Bid. ESCO's may request an ESCO letter of authorization for Orange and Rockland Utilities to obtain gas usage, profile information and interval data. Please send request to purchasing@co.rockland.ny.us.
- 7.16 In submitting a Bid, the bidder acknowledges that it waives any and all claims and causes of action against all participating County of Rockland Agencies, the members of NORESCO LLC or any of their officers, directors, representatives, members, employees, principals, consultants and agents, on the basis of the historical usage that the bidder may have relied upon. The Agreement will not be on a "take-or-pay" basis.

#### 8. CONTRACT QUANTITIES

Contract Quantities shall be determined by historical consumption patterns for each account and shall be mutually agreeable to both the contracting agency and the Awarded ESCO.

#### 9. TERM OF CONTRACT

Contract Term shall be for a period to be determined by the pricing option selected by the County and deemed by the County to be in the best interest of the County.

The service start date for all IT natural gas accounts must be the meter read on or after December 31, 2022. All natural gas contracts will be coterminous.

Each Agency must contract with and be billed separately by the Awarded ESCO for its natural gas supply.

The General Terms & Conditions in Appendix "A" are in addition to the ESCO's standard Terms & Conditions. Any contract awarded must be executed on the ESCO's New York State Sales Agreement, pending approval of contract language by the County Attorney, as stated in the RFB Specifications.

#### 10. AVAILABILITY OF FUNDS

Pursuant to New York State Law any contract(s) resulting from this Bid shall be subject to the annual availability and appropriation of sufficient funds.

Bids will be evaluated by the County's Energy Consultant and Awards shall be made to the lowest responsible bidder(s) meeting the requirements of the Bid.

It is the intention of the County to notify the winning bidder of award within 3 hours of the bid opening. Any Award will be pending approval of the applicable ESCO's contract terms and conditions by the County's Attorney.

RCC reserves the right to have its own attorney review and approve the Awarded ESCO's contract terms and conditions.

The County reserves the right to reject any and all Bids, in whole or in part, submitted in response to its RFB.

#### 12. PIGGY BACKING

As per New York State General Municipal Law, all political subdivisions of New York State are allowed to make purchases through the resulting contract(s). As per Rockland County Procurement Policy, Rockland County based Non-Profit Agencies approved to participate in New York State's Contract Extension Program are authorized to make purchases through the resulting contract(s). This type of procurement option is called "piggy backing."

Should any government agency contact the Awarded ESCO(s) seeking an electricity and/or natural gas contract based on the County Award(s), ESCO shall immediately direct them to the County's Energy Consultant of Record. Based on market conditions, the awarded ESCO(s) shall have the option of offering the same (or better) contract price(s) to other government agencies and Rockland County based non-profits provided such contract is executed under the same terms and conditions of the County's approved contract.

ESCO(s) acknowledge, and agree, that any additional contract(s) by way of "piggy backing" shall be under the same terms and conditions of the County's contract and executed through NORESCO. Consulting fees shall be the same as the County Bid, and any price offered to additional Agencies shall be inclusive of that cost. Consulting fees on piggybacked contracts shall be payable to NORESCO.

At no time shall the addition of any Agency negatively impact Bid prices for the County of Rockland or Rockland Community College.
