As per the New York State General Municipal Law, all political subdivisions of New York State are allowed to make purchases through the resulting contract(s). As per Rockland County Procurement Policy, Non Profit Agencies approved to participate in New York State's Contract Extension Program are authorized to make purchases through the resulting contract(s).

1. The County of Rockland shall make all contract award information available to other political subdivisions and non profit agencies through our website: www.rcpurchasing.com
2. Any other political subdivision or Rockland County non profit agency will issue purchase orders directly to vendors within the specified contract period referencing the County's contract and shall be liable for any payments due on such purchase orders; and shall accept sole responsibility for any payment due.
3. All purchases shall be subject to audit and inspection by the other political subdivisions and Rockland County non profit agencies for which the purchase was made.
4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non profit agencies authorized to use New York State's contracts, if called upon to do so. A listing of approved Rockland County non profit agencies is available on the Purchasing Division's website at www.rcpurchasing.com. The County, however, will not be responsible for any debts incurred by the participants pursuant to this or any other agreement.
6. Necessary deviations from the County's specifications in the award of a participant contract, whether such deviations relate to quantities, or delivery points shall be resolved between the successful bidder and the other political subdivisions and Rockland County non profit agencies.

SPECIFICATIONS

1. SCOPE

- 1.1. This bid is to establish fixed pricing to furnish and deliver the specified replacement parts for GE Controls RX3i Series located at various pump stations throughout the County of Rockland.
- 1.2. Contract to be in effect for one year from the date of award with four (4) one (1) year option terms. Renewal terms are to be by mutual agreement by the County of Rockland and the Vendor. (See Price Adjustment Clause on item 6 of this document.)
- 1.3. The quantities listed on the proposal pages are estimates, items purchased will depend on the requirements of the Rockland County Sewer District #1 (RCSD).

2. REQUIREMENTS for GE RX3i Parts

- 2.1. The replacement parts specified must be (OEM) Original Equipment Manufacture, with Warranty, or approved equal.
 - 2.1.1. GE RX3i Controls are installed in all thirty (30) sites including remote pump stations, screening facility.
 - 2.1.2. Replacement parts ordered shall be installed by others.
 - 2.1.3. COMPATIBILITY
 - 2.1.3.1. The replacement parts offered must have the ability to connect with the existing equipment without the use of adapters. Bidder must guarantee compatibility in writing with the bid.

3. APPROVED EQUAL OR EQUIVALENT ITEMS

- 3.1. Bidder must submit with their bid, all brochures, specifications etc. along with comparative analysis proving the proposed alternate is "equal". It is the Bidder's responsibility to provide a complete analysis comparing the alternate to the specified item. If this is not received, the bid may be deemed non-responsive.
- 3.2. Bidder must guarantee in writing, the compatibility of the item bid, with existing equipment, without the use of an adapter or retrofit. This must be submitted, in writing, with bid or the bid may be deemed non-responsive. Bidder must be able to demonstrate within 5 business days of request to show the compatibility of the item bid, with existing equipment, without the use of an adaptor or retrofit.
- 3.3. In the event that an alternate is bid, the County of Rockland reserves the right to request a demonstration of the specific model bid at the RCSD#1 facility at the Contractor expense. Failure to furnish demonstration, within 5 business days of request, will render the bid, for that item, as non-responsive.
- 3.4. Bidder must provide a list of 3 installations where items bid are being used with the same type of equipment that is being utilized by the Rockland County Sewer District # 1. The equipment shall have been in use for a minimum of three years. References need to include location, contact name, email and telephone number of each installation.
- 3.5. The County of Rockland will make the final determination on whether the equipment is considered an equal.

4. DELIVERIES

- 4.1. All parts must be delivered Monday – Friday, excluding holidays, between the hours of 8:00 AM – 2:00 PM to RCSD#1 located at 4 Route 340, Orangeburg, NY 10962.

5. PRICING

- 5.1. Pricing must include delivery, FOB Destination.
- 5.2. Bidders must include the Mfg. and Product/Part Code in the space provided on the proposal pages. Failure to provide this information at the time of bid may render your bid non-responsive.

6. CONTRACT PRICE ADJUSTMENTS

- 6.1. The County recognizes this product or service has a price component that may have a commodity with changing costs. The Contractor/Supplier may request a Price Adjustment each year upon a contract renewal request.

A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (ie, commodity increases), the current pricing, and the requested revised pricing.

The County will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County will provide a written explanation in support of the decision.

The Director of Purchasing may use available indexes (e.g. CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that exceeds 5% will not be approved unless very unusual and significant changes have occurred in the industry.

In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices/pricing that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation.

7. AWARD

- 7.1. This contract is intended to be awarded as a whole, to the lowest responsible responsive bidder.
- 7.2. The County of Rockland reserves the right to award this contract on a line-by-line basis to the lowest responsible responsive bidder(s).
