Any other political subdivision or Rockland County nonprofit agency will issue purchase orders directly to vendors within the specified contract period referencing the County's contract and shall be liable for any payments due on such purchase orders; and shall accept sole responsibility for any payment due.
3. All purchases shall be subject to audit and inspection by the other political subdivisions and Rockland County nonprofit agencies for which the purchase was made.
4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County nonprofit agencies authorized to use New York State's contracts, if called upon to do so. A listing of approved Rockland County nonprofit agencies is available on the Purchasing Division's website at [www.rcpurchasing.com](http://www.rcpurchasing.com). The County, however, will not be responsible for any debts incurred by the participants pursuant to this or any other agreement.

## SPECIFICATIONS

### 1. SCOPE

- 1.1. The purpose of this bid is to establish an annual agreement(s) for a percent discount off the current marked retail price for various hardware supplies and related equipment. The following are specifically excluded from the contract: lumber, electrical and floor covering supplies.

### 2. AWARD VALUE

- 2.1. The dollar amount of the annual requirement may be in excess of twenty-five thousand dollars (\$25,000.00). This is an estimated amount only and is subject to fluctuation in accordance with actual requirements.

### 3. DISCOUNT FROM CURRENT MARKED RETAIL PRICE

- 3.1. The price bid shall be in the form of a percent discount from the current marked retail price. Bidders shall enter, in the space provided, the applicable discount, which shall remain firm for the life of the contract. **Please fill out and return page 7 for evaluation purposes.**

- 3.1.1. Discounts offered must be expressed as a percentage figure. Offers containing chain or multiple discounts may be considered non-responsive.

### 4. RESTRICTIONS

- 4.1. Bids containing restrictions will not be acceptable unless the Rockland County Purchasing Department deems the restrictions conform to the County requirements.

### 5. RESERVATIONS

- 5.1. Items specified herein of unusual quantities which the County considers other than "routine requirements" may, at the discretion of the Purchasing Officer, be re-submitted to public bid on an individual item basis whenever, in the opinion of the Purchasing Department, the best interest of the County will be served. It is anticipated that any single order exceeding Ten Thousand Dollars (10,000.00) will be subjected to separate bidding and some common usage items will be consolidated for "scheduled buying" on a separate bid basis.

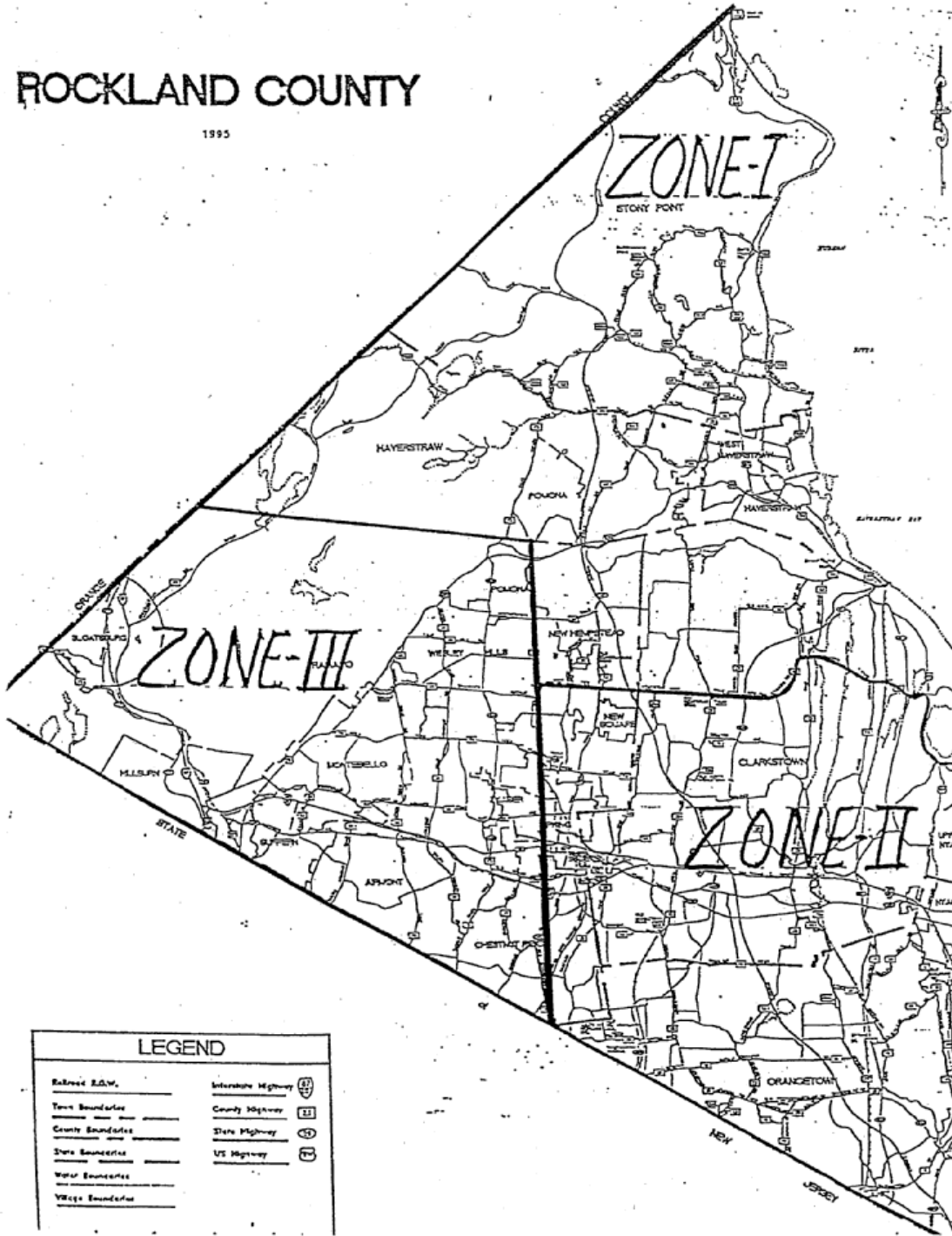
**9. AWARD**
