No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non-profit agencies authorized to use New York State's contracts, if called upon to do so. SPECIFICATIONS

1. SCOPE

- 1.1. The contractor shall provide all labor, material, equipment, and supervision required to perform maintenance and repair services to County Government roofs as per the specifications herein. The work involves the repair and/or maintenance of various EPDM and PVC single ply roofs, foam roofs, shingled roofs, and asphalt and coal tar built up roofs, including insulation, pavers, gravel, etc. incorporated into the roofing system. Roof repairs and maintenance shall be complete systems including flashing, sealants and perimeter metals. Repairs to built-up roofs may be in either hot or cold applied roofing as required by the owner. All work will be done on as needed, call in basis.
- 1.2. Contractor shall provide roof replacement services for all County of Rockland facilities on an as needed basis. The work includes all labor, supervision, materials including flashing, sealants and perimeter metals, equipment, removal and disposal services of existing roofing, permits and licenses necessary to complete projects.
- 1.3. Projects valued up to the Public Works threshold of \$35,000.00 may be assigned directly by the user department. No project is to proceed without the issuance of a duly authorized purchase order.
- 1.4. Projects valued over \$35,000.00 must be submitted by the user department to the Director of Purchasing requesting authorization to proceed. Requests must include complete scope of work and detailed cost breakdown including a total Not to Exceed amount.
 - 1.4.1. The County of Rockland reserves the right to issue a separate bid for specific projects if it is determined to be in the best interest of the County.

2. TERM OF CONTRACT

- 2.1. Contract shall be valid for a period of one (1) year with the option to renew for three (3) additional one (1) year terms.
- 2.2. Renewals are subject to a mutual agreement between the contractor and the County of Rockland.

3. CONTRACTOR'S RESPONSIBILITY

- 3.1. Prior to bidding, contractor shall carefully examine all equipment and specifications and shall make all necessary investigations required to inform himself thoroughly and fully as to the work required under these specifications. Appointments can be scheduled by contacting the individuals listed in section six- Facility Locations and Contact Person.

4. QUALIFICATIONS OF CONTRACTORS

- 4.1. The contractor shall demonstrate that they, or the principals assigned to perform work under this contract, have successfully completed services similar to those specified in this RFB, are normally and routinely engaged in performing such services and are properly and legally licensed (if required) to perform the work. Contractor should include the following with their bid:
 - 4.1.1. 4.1.1.1. The contractor should submit with their bid references to demonstrate they, or the principals have performed preventive maintenance, service, repairs and installation of roofing systems similar to those specified in this specification.

4.1.2. The contractor is required to have an experienced labor force adequate to perform the required work in an efficient and expeditious manner.

4.1.2.1. The contractor should submit with their bid the names of the service technicians that will perform work under this contract, their function in the company, title, and number of years of service with the contractor's firm.

4.2. The contractor shall be authorized by the manufacturer to perform warranty repairs on Carlisle, Firestone and Sarnafil roof systems. Built up roofing system contractor must be authorized by one manufacturer of a major built up roofing system.

4.2.1. Authorizations should be submitted with the bid.

5. EMERGENCY/REPAIR OR REPLACEMENT WORK

5.1. The contractor shall only perform repair/replacement work which is required. Repairs/replacement shall be performed only with the authorization of the Rockland County authorized representative. Should any repair/replacement work be performed without authorization, payment will not be made.

5.1.1. Prior to the commencement of work, contractor shall submit a written Not to Exceed estimate based on the detailed pricing awarded. The County will not authorize payment in excess of this estimate without prior written authorization. The estimate shall contain the following:

5.1.1.3. Estimate of labor hours by trade and hourly rates.

7. TRAVEL TIME

- 7.1. All labor shall be billed from the time contractor's employee arrives at, to the time he departs from, the Rockland County job site. The County of Rockland will not accept nor authorize payment for travel time or expenses of service personnel to any of the County of Rockland's facility locations. The only billable time will be for service work performed.

8. WARRANTY

- 8.1. The contractor shall warranty all work performed for a period of one year.

9. SAFETY

- 9.1. The contractor shall adhere to all Federal, State, OSHA, PESH and County of Rockland safety rules while the work is in progress. Contractor is responsible for any damage to vehicles or structures resulting from the contractor's negligence.
- 9.2. Contractor shall maintain the work site in a clean and orderly fashion. All debris shall be cleaned and removed from the work site each day.

10. LABOR AND MATERIAL COSTS

- 10.1. Contractor shall quote a labor rate in dollars per man-hour (\$/man-hour) to make repairs to the roof systems specified during regular work hours. A labor rate (\$/man-hour) shall also be quoted to cover emergency repairs at all times other than regular hours.
- 10.2. Invoices for labor must be billed to the next quarter hour of actual time worked (example: 8:00 AM to 9:10 AM would be billed at 1 hour and 15 minutes). Invoices rounded to the next full hour will not be approved for payment.
- 10.3. Materials shall be charged to the owner by the contractor at the contractor's cost, plus their percentage for overhead and profit.
- 10.3.1. Percent Markup bid shall not exceed 15%. There shall be no markup on freight.
- 10.3.2. Contractor will be required to provide proof of cost at time of billing. Contractors shall indicate on the bid their additional percentage mark-up to material. If hot kettles are requested or required for repairs, the owner shall pay only the material costs. There shall be no additional charges, except labor and material as specified herein, for providing kettles. Work tickets detailing all labor and material provided shall be given to the owner at the time of service call completion. Contractor shall provide the proper manpower necessary to complete the work in a safe and timely manner. Daily work tickets shall be provided for extended work (work requiring more than one day to complete).
- 10.4. Contractor shall have material safety data sheets on site for all applicable materials used during the performance of their work.

11. WORK HOURS

- 11.1. All work shall be performed during regular hours of 7:30 AM to 4:00 PM, Monday through Friday. Contractor shall respond on site to calls for emergency repair or service within 4 hours of notification. Most service repair calls will normally be prescheduled.

12. LAWS AND PERMITS

- 12.1. Contractor shall comply with all applicable Federal, State and Municipal Laws as required, to perform all work as specified.

17. CLEANING UP
