SPECIFICATIONS

1. SCOPE

1.1. The County of Rockland is looking for a contractor to perform service and repair work of grounds keeping / commercial lawn equipment for Rockland County facilities.

2. REQUIREMENTS

2.1. Contractor shall provide all labor, material, equipment and supervision required to perform preventive maintenance, diagnostic and repair service. Rockland County facilities include but are not limited to the Dr. Robert L. Yeager Health Center and Rockland County Fire Training Center in Pomona, Rockland County Government Center in New City, Rockland County Sewer District #1 in Orangeburg, Rockland County Highway Department, and the Rockland County Environmental Resources.

3. EXPERIENCE

3.1. Contractor must have a minimum of three (3) years' experience in the repair and servicing of grounds keeping / commercial equipment. Contractor to include with their bid response, a list of equipment and brands/manufacturers they are authorized to service and repair (Appendix B). This form will be used for evaluation purposes only.

4. REFERENCES

4.1. Contractor must submit with their bid a list of five accounts for which they are presently doing such work. Reference must include contact person and telephone number. The contractor's primary business must be in the sales, service and repair of grounds keeping / commercial lawn equipment (see page 24 of the bid specifications.).

5. PERSONNEL

5.1. Contractor must have sufficient staff experienced in the service and repair of grounds keeping / commercial lawn equipment as required under these specifications.

6. PARTS

6.1. Contractor guarantees to use new genuine OEM parts specifically designed and manufactured for use with original equipment listed in the bid proposal pages, or new owner approved equal, to make all repairs as required under this agreement.

7. COVERAGE

7.1. Contractor shall supply a list of days and hours of business available for servicing of equipment.

8. RESPONSE TIME

8.1. All repairs must be completed within five (5) working days or sooner unless approved by the Authorized Representative for the County of Rockland.

9. PRICING FOR LABOR AND MATERIAL

9.1. Contractor must submit an hourly labor rate as per attached pricing schedule indicated on the proposal pages. All parts and materials shall be offered as a Percent Discount from Manufacturer's Suggested Resale price as indicated on proposal pages (Line #2-1 thru 2-19). Line #2-18 on the proposal page, is for miscellaneous brands / manufacturers not individually listed. If a single discount is offered for balance of brands / manufactures listed on "Appendix C", please enter discount in the appropriate column of Line #2-18. If the discount offered for line #2-18 will vary by brand/manufacture, you may list discount being offered on "Appendix B" next to each authorized brand / manufacturer. Line #2-19 will not be used for evaluation.

10. BRANDS/MANUFACTURERS

- 10.1. The Brands/Manufacturers listed below are examples of some of the Brands/Manufacturers currently owned by the County of Rockland.

11. WARRANTY

11.1. Contractor is to guarantee all repair work performed to be free from defects in materials and workmanship for ninety (90) days. Additionally, new parts shall carry the manufacturer's standard warranty for that part. Any faulty part shall be immediately replaced by the contractor without any cost to the County of Rockland.

12. WORK ORDER

12.1. Upon job completion / pick-up, service center must submit a **legible** job ticket to owner indicating date, equipment, actual hours of work, work performed, parts used.

13. INVOICING

- 13.1. Detailed and legible description of all completed repair work must accompany all invoices.
- 13.2. Detailed billings must be received by the County of Rockland within fifteen days after completion of each repair.
- 13.3. The contractor's invoice must list the number of man-hours worked. The contractor's labor charges must correspond to the rates, which he will supply with the bid. The contractor agrees and hereby certifies that all labor charges contained in the bid's invoices and vouchers shall be only those that were required and necessary to complete the required work.
- 13.4. Invoices must contain Manufacturer, Name of Part, Part number, Suggested Mfg. Resale Price, Discount Offered and the net price. Invoices not submitted in this format will not be paid until corrected.
- 13.5. Contractor shall receive a purchase order number from the Ordering Department prior to commencing work.

13.6. All invoices for labor must be billed to the next quarter hour of actual time worked (example 8:00 am to 9:10 am would be billed at one (1) hour and 15 minutes. Invoices rounded to the next full hour will not be approved for payment.

14. EQUIPMENT

14.1. The contractor is responsible for providing all tools and equipment necessary to efficiently perform all work in a professional and workmanlike manner. The Certificate of Equipment must be completed and included with the proposal forms.

15. TRAVEL TIME

15.1. The County of Rockland will not accept nor authorize payment for travel time or expenses of service personnel to any of the County of Rockland's facility locations. The only billable time will be for service work performed. On occasion, a piece of equipment may need to be towed or transported to and from service center. Towing/transportation charges, Line #3 on the proposal page, are for the one-way cost of transporting equipment, as needed.

16. SAFETY

16.1. The contractor must perform all work in accordance with OSHA and County Safety Regulations.

17. DURATION AND PRICE ADJUSTMENT

- 17.1. The term of this contract shall be for a period of one year from its effective date, with the option for three (3) additional one-year periods.
- 17.2. Prices are firm for the first year of the contract. In the second (2) through fourth (4) year of the contract, the contractor may receive a price adjustment.
- 17.3. Any price adjustment will be limited to the percent increase in the CPI Index-All urban Consumers for the preceding twelve (12) months. Consumer Price Index (CPI) is published by the U.S. Department of Labor.
- 17.4. The decision to extend or not to extend the contract rests solely with the County of Rockland.

18. **AWARD**

18.1. Award will be made to the lowest responsible bidder based on the evaluation criteria. At the discretion of the Director of Purchasing, there may be multiple awards based on the overall list of authorized Brands/Manufacturer's supplied at time of bid which best covers the needs of the County of Rockland. All quantities shown are estimates, and the successful bidder will be required to furnish quantities that may be more or less than the listed estimated quantities. Appendix A will be filled in by purchasing to determine travel time to vendors facility and used in the award determination process.
