SPECIFICATIONS

1. SCOPE

1.1. The scope of this bid is to provide pricing for specified catch basins, frames, grates, and curbs for the County of Rockland Highway Department, specified manhole castings and risers for the Rockland County Sewer District #1 and other county agencies as needed and various locations in Rockland County. Estimated quantities will be placed on an as needed basis.

2. GENERAL REQUIREMENTS

- 2.1. Catch Basins, Frames, Grates, and Curbs,
 - 2.1.1. Bids submitted for frames and grates shall show a unit price for the pattern listed on the proposal pages. A separate price shall be quoted for delivery and unloading of the frames and grates at the Highway Department Yard on Wood Ave, Stony Point, NY 10980 if not included in the unit price.
 - 2.1.2. Pattern numbers for frames and grates to be furnished are those used by Campbell Foundry, Harrison, NJ, Expanded Supply Products, Cold Spring, NY, or an <u>approved</u> equal. **Any deviations in dimensions must be noted**.
 - 2.1.3. Frames and grates to be furnished are similar to Campbell 3408, 3405, 2617, 2611, 2610 and ESP 2639BP or approved equal. See proposal pages for specifications and measurements. All grates are to be bike safe.
 - 2.1.4. All frames and grates are to be New York State Department of Transportation approved.
 - 2.1.5. Bidders are advised that the delivery of catch basins, frames, grates and curbs, will only be accepted between the hours of 7:00 am and 2:00 pm, Monday through Friday, vendor must call in advance to arrange delivery.
 - 2.1.6. Bidders shall ensure that the catch basins, frames, grates, and curbs are unloaded in the presence of a designated representative and a receipt signature of acceptance is provided.
 - 2.1.7. The County of Rockland reserves the right to reject any catch basins, frames, grates, and curbs found damaged upon delivery, damaged during unloading, or in the opinion of the designated representative does not meet these specifications.
 - 2.1.8. In accordance with paragraph 2.1.7, the bidder shall replace any catch basins, frames, grates and curbs rejected by the County of Rockland, at no additional cost.
 - 2.1.9. Bids will only be considered from firms normally engaged in providing the type of commodity specified herein. The County of Rockland reserves the right to inspect the bidder's facility, equipment, personnel, and organization at any time, or to take any other action needed to determine bidder's ability to perform. The County shall reject bids where evidence or evaluation is determined to indicate inability to perform.
- 2.2. Manhole castings and risers,
 - 2.2.1. Manhole Castings and Risers shall conform to the requirements of current A.S.T.M. specifications for gray iron castings (designation A48-48). Manhole Castings and Risers and covers shall be heavy duty and be rated for a minimum of A.A.S.H.T.O. H20-16-wheel loads.
 - 2.2.2. Bids submitted for Manhole Castings and Risers shall show a unit price for the pattern listed on the Proposal pages. The unit price shall include delivery and unloading of the Manhole Castings and Risers at any location within Rockland County. **Delivered price shall be for a minimum quantity of 5 pieces.**

- 2.2.3. Pattern numbers for Manhole Castings and Risers to be furnished are those used by Campbell Foundry, Harrison, NJ, General Foundries, North Brunswick, NJ or by Neenah Foundry Company, Neenah, Wisconsin or an approved equal. **Any deviations in dimensions must be noted.**
 - 2.2.3.1. If offering an equal, vendor shall be required to set up a field test for approval of items offered within 5 business days after notification.
- 2.2.4. Manhole Castings to be furnished as needed are, Campbell 1203&B, Neenah R-1559 or General 12683, Storm Manhole Frame & Cover. Cover shall have two penetrating pick holes approximately 1 ½" wide by 2" long and be of non-skid design. Cover shall have a minimum weight of 120 pounds and measure 25 ¾" in diameter. Cover shall have 1 ¾" raised lettering on its non-skid design. Lettering to be determined at time of order.
- 2.2.5. Riser Extensions are to be for 25-3/4" and 23" diameter covers for Campbell 1203 and 1005 Manhole Castings. 25-3/4" diameter covers for Neenah R-1559 Manhole Castings and 25-3/4" diameter covers for General Foundry 12683 Manhole Castings. Also supply locking cover 1478.
- 2.2.6. Bidders are advised that the delivery of Manhole Castings and Risers will only be accepted between the hours of 8:00 am and 3:00 pm, Monday through Friday, unless other arrangements are made.
- 2.2.7. Bidders shall ensure that Manhole Castings and Risers are unloaded in the presence of a designated representative and a receipt signature of acceptance is provided.
- 2.2.8. The County of Rockland reserves the right to reject any Manhole casting or riser found damaged upon delivery, damaged during unloading, or in the opinion of the designated representative does not meet these specifications.
- 2.2.9. Any Manhole Castings or Risers rejected by the County of Rockland in accordance with paragraph 2.2.8 above shall be replaced by the bidder at no additional cost, including return and re-supply shipping, to the County of Rockland.
- 2.2.10. Bids will only be considered from firms normally engaged in providing the type of commodity specified herein. The County of Rockland reserves the right to inspect the bidder's facility, equipment, personnel, and organization at any time, or to take any other action needed to determine bidder's ability to perform. The County of Rockland shall reject bids where evidence or evaluation is determined to indicate inability to perform.

3. GUARANTIES/WARRANTEES

3.1. Bidder shall submit all guaranties and warrantees with the Bid Proposal.

4. BRAND NAME

4.1. The use of a brand name is for the purpose of describing the standard of quality, performance, and characteristics desired and are not intended to limit or restrict competition.

5. APPROVED EQUAL OR EQUIVALENT ITEMS

- 5.1. Bidder shall submit specifications, cut sheets, and brochure data with his bid if bidding on an equal or equivalent item. If bidders do not include required information on alternate items, bid will be rejected.
- 5.2. The County of Rockland will consider imported items but would prefer domestic castings.
- 5.3. Bids containing equal or equivalent product shall contain a written side by side comparison to the Campbell, Neenah, or General Foundry product. This analysis (Section 8) shall be included with the bid submittal.

- 5.4. Bidder shall submit a written affirmation that the product being offered meets or exceeds the specified product.
- 5.5. Bidder shall indicate Mfg. and Model # on the proposal pages.

6. CONTRACT PRICE ADJUSTMENTS

- 6.1. The County of Rockland recognizes this product or service has a price component that may have a commodity with changing costs. The Supplier may request a Price Adjustment no more frequently than once each quarter (3-month period).
- 6.2. A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (i.e., commodity increases), the current pricing, and the requested revised pricing.
- 6.3. The County of Rockland will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County of Rockland will provide a written explanation in support of the decision.
- 6.4. The Director of Purchasing may use available indexes (e.g., CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that exceeds 5% will not be approved unless very unusual and significant changes have occurred in the industry.
- 6.5. In the event industry costs decline, the County of Rockland shall have the right to receive, from the Supplier, a reasonable reduction in prices/pricing that reflect such cost changes in the industry. The County of Rockland will make a written request to the Supplier for a Price Adjustment in writing with supporting documentation

7. AWARD

- 7.1. Sections 1-4 of the proposal pages shall be awarded <u>by Section</u> to the lowest responsive/responsible bidders meeting the stated requirements.
- 7.2. Section 5 of the proposal pages shall be awarded line by line to the lowest responsive/responsible bidders meeting the stated requirements.
- 7.3. No awards will be made until all alternate product specifications, if applicable, are reviewed by the Rockland County Department utilizing the items requested on the proposal pages.
