## **SPECIFICATIONS**

#### 1. **SCOPE**

1.1. The scope of this bid is to provide Overt Concealment Boxes, Pedestal Housing Concealment and Three Window Medium Concealment packages inclusive of modems, cameras and all accessories for the surveillance of County roadways as specified. (See pages 14 & 15 for all specifications). Pricing on proposal pages is grouped by individual package inclusive of cameras, modems and accessories.

#### REQUIREMENTS

- 2.1. All items must be as specified or approved equal or equivalent.
- 2.2. Bids containing restrictions will not be acceptable unless the County of Rockland Purchasing Division deems the restrictions conform to County of Rockland requirements.
- 2.3. Equipment being submitted MUST work with existing surveillance and transmitting systems, and wireless remote Interface equipment.
- 2.4. All prices bid, are to include freight and delivery.

#### 3. QUANTITIES

- Quantities provided are for evaluation purposes. The County reserves the right to order quantities above or below those stated on the proposal pages.
- Vendor is to offer a percent discount from manufacturers suggested price list. All discounts must be 3.2 firm and fixed for the first year of the contract. If uploaded on the Bonfire portal, the Percent Discount is to be entered as a whole number EX:10%= 0.10 on the proposal pages.

#### NONRESTRICTIVE USE OF BRAND NAME OR EQUAL SPECIFICATIONS

4.1. The use of a brand name is for the purpose of describing the standard of quality, performance, and characteristics desired and is not intended to limit or restrict competition.

#### 5. APPROVED EQUAL OR EQUIVALENT ITEMS

- 5.1. Bidder must submit specification, cut sheets, and brochure data with the bid submission if bidding on an equal or equivalent item. Bidders must also include a company name, address, contact and contact telephone number of where the product is currently being utilized.
- 5.2. If the bidder is bidding an approved equal, he must provide references showing locations the County of Rockland can visit of the exact make and model intended to be supplied. If bidding an alternate or

approved equal, <u>two copies</u> of brochures, specifications, and any other pertinent information must be sent with bid.

- 5.3. In the event that an alternate is bid, the County of Rockland reserves the right to request a demonstration of the specific model bid. Failure to furnish the demonstration will render the bid, for that item, as non-responsive.
- 5.4. Any units not conforming to these specifications may be rejected, and it will be the responsibility of the manufacturer to conform to the requirements unless exceptions have been specifically cited by the bidder and acceptance made on the basis of the exceptions. Each bidder is required to respond to every requirement in this specification with the appropriate explanation of equipment when specified and supply all requested information with bids.
- 5.5. The County of Rockland will make the final determination on whether the equipment is considered an approved equal.

#### 6. PROPOSAL PAGE

- 6.1. The Proposal Pages shall be completed accurately. An extended price shall be entered in the column indicating "Extended Price".
- 6.2. Bidder shall submit the actual manufacturer's brand name and part numbers for equipment being bid. (This includes bids submitted for equivalent or as specified equipment) in the space provided on the Proposal Pages. In addition, Bidder must indicate vendor stock numbers.

#### 7. EQUIPMENT REQUIREMENTS

- 7.1. Cameras are to be configured with Verizon SIM cards supplied by the County of Rockland.
- 7.2. Equipment must be able to be deployed upon receipt.
- 7.3. Equipment must be new, unused in original packaging.
- 7.4. Equipment shall have standard manufacturer's warranty. Standard manufacturer's equipment warranty is to be included in bid response.
- 7.5. Training and technical support on equipment is to be provided on an ongoing basis at no additional cost.

#### 8. AWARD

8.1. Bid will be awarded in its entirety to the lowest responsive responsible Bidder based on overall bid price indicated on proposal pages and who meets all the stated requirements.

#### 9 PRICE ADJUSTMENTS

- 9.1 The County recognizes this product or service has a price component that may have a commodity with changing costs. The Contractor/Supplier may request a Price Adjustment no more frequently than once each quarter (3 -month period).
- 9.2 A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (i.e., commodity increases), the current pricing, and the requested revised pricing. The County will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County will provide a written explanation in support of the decision.
- 9.3 The Director of Purchasing may use available indexes (e.g., CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that exceeds 5% will not be approved unless very unusual and significant changes have occurred in the industry. In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices/pricing that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation.

#### 10 PRICELISTS

10.1 A copy of the current Manufacturers' Price list and/or Nationally Offered Vendor Catalog and Price List or approved equal items shall be included with the bid response. Once awarded a contract, the percentage discount offered to authorized users may, at the contractor's option, be increased based on individual orders. Discounts may be greater, but in no instance shall they be lower than the awarded discount. If contractor is offering a single discount structure, the same discount is applied to all purchases made from the contractor's pricelist.

#### 11 PRICELIST UPDATES

11.1 Upon approval of the contract by the Purchasing Director, contractors may update their contract product line to reflect manufacturer's addition of new products as established by the manufacturer in their normal course of business and new product pricing. Contractors will be allowed to update their product line annually. All product list updates must first be approved in writing by the Purchasing Director before they become effective. All percentage discounts bid will remain firm (unchanged) for the duration of the resulting contract.
