- 1.1. This bid is for pricing for specified replacement parts for the sewage bar screen located at the Rockland County Sewer District #1. This bid includes the Rockland County Sewer District #1 and various locations in the County of Rockland. Orders will be placed on an as needed basis. Items shall be WSG Solutions or approved equal.
 - 1.1.1. The existing sewage bar screen was manufactured by FMC and is a cog rake bar screen similar to a WSG MODEL GA.

2. GENERAL REQUIREMENTS

2.1. INTER-CONNECTABLE

2.1.1. Bidder must submit a written guarantee with the Bid Proposal stating that equipment being bid is inter-connectable with the existing environment without the use of adapters.

2.2. EQUAL OR EQUIVALENT ITEMS

- 2.2.1. As stated in 2.1.1, Bidder shall submit a written guarantee with the Bid Proposal stating that item being bid is inter-connectable with existing equipment.
- 2.2.2. Bidder shall submit all specifications, drawings, cut sheets, catalogs, and a side-by-side comparison defining the differences between the alternate product offered and how it meets and or exceeds the requirements of the specified equipment. This must be uploaded with your bid submission, failure to comply may result in your bid being deemed non-responsive and removed from consideration of award.
- 2.2.3. Bidder shall provide a list of five locations having installations of the size and type of equipment specified and which have been in operation for at least five years. Include location, address, equipment, contact and telephone number.

5.3. SECTION III - % MARK-UP ON PARTS FABRICATED

- 5.3.1. <u>Bidder shall submit a % Mark-Up on Contractor's cost for the fabrication of materials that may be needed and not specifically listed in SECTION I of this bid and are needed for the repair of the Sewage Bar Screens.</u> All material to be billed at contractor's cost, plus a percent mark-up. The mark-up must correspond to the figure entered on the proposal pages on this bid.
 - 5.3.1.1. No additional material shall be delivered without a Purchase Order issued from the authorized representative of the County of Rockland.
 - 5.3.1.2. <u>Material Costs</u>: The invoice must list all parts which the contractor has purchased from other sources and the cost or the cost to fabricate the parts needed. Receipts for all materials purchased which cost more than \$100.00 must be submitted with each invoice. The bidder agrees and hereby certifies that all parts and materials shall be at the lowest price available. Invoices will not be paid without this documentation.

6.5. Quantities listed on the Bid Submission Pages are estimates and for evaluation purposes. Actual quantities ordered may be more or less than those listed depending on the requirements of the Rockland County Sewer District #1.

7. PRICE ADJUSTMENT

The County recognizes this product or service has a price component that may have a commodity with changing costs. The Contractor/Supplier may request a Price Adjustment no more frequently than once each quarter (6-month period).

A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (ie, commodity increases), the current pricing, and the requested revised pricing.

The County will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County will provide a written explanation in support of the decision.

The Director of Purchasing may use available indexes (e.g. CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that exceeds 5% will not be approved unless very unusual and significant changes have occurred in the industry.

In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices/pricing that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation.
