#### 1. SCOPE

1.1. The scope of this bid is to establish a three-year agreement for a percent discount off the current manufacturer's price list for various Law Enforcement, EMS and Fire & Emergency Services equipment & related supplies purchased by various departments and other authorized users.

#### 2. MANUFACTURER'S

- 2.1. The County of Rockland will only accept discounts from manufacturer's suggested retail/list pricing.
- 2.2. The County of Rockland prefers web-based manufacturers with published pricing.
- 2.3. Bidders are to be submitted as a percent discount off offers against the identified manufacturers on the proposal pages.
- 2.4. Those bidders wishing to offer discounts from other manufacturers of an equivalent quality may submit their offers on **Schedule A** to be included with your physical bid. Unless there is competition for a specific manufacturer listed on the Schedule A, no award will be made.
- 2.5. Bidders are limited to listing three (3) additional manufacturers on the Schedule A.

#### 3. PRICING/DISCOUNTS

- 3.1. The price bid must be in the form of a percent discount from manufacturer's suggested retail list price. Suggested retail list price shall be defined as that published on the manufacturer's current web page or in their latest standard printed price list for that specific year. Bidders are to enter, in the space provided on the proposal pages, the applicable discount which will remain firm for the life of the contract.
- 3.1.1. Bidders will submit a current manufacturer's URL or their suggested retail price list along with a catalog for each manufacturer bid.
- 3.1.2. If price list shows more than one (1) column of prices, bidders are to clearly mark which price column is applicable.
