3. All purchases shall be subject to audit and inspection by the other political subdivisions and Rockland County non profit agencies for which the purchase was made.
4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non profit agencies authorized to use New York State's contracts, if called upon to do so. ## **SPECIFICATIONS**

### **1. SCOPE**

- 1.1. The scope of this bid is to provide seventy (70) Getac S410 G5 Laptops with Wifi Only and Five (5) Getac S410 Laptop LTE Connectivity, fifteen (15) Getac Dual Bay Battery Charger and fifteen (15) Getac Spare battery or approved equal.
- 1.2. The County of Rockland currently has a request for laptops and accessories as specified on proposal pages and in bid specifications.
- 1.3. Additional quantities may be required and will be ordered on an as needed basis.

### **2. REQUIREMENTS**

- 2.1. All items must be as specified, approved equal or equivalent.
- 2.2. Bids containing restrictions will not be acceptable unless the County of Rockland Purchasing Division deems the restrictions conform to County of Rockland requirements.
- 2.3. All prices bid shall include freight and delivery.
- 2.4. Equipment warranty shall include Getac's (3) year warranty
- 2.5. Getac S410 G5 Wifi ONLY must be equipped with Intel Core i7-1360P Processor, Windows Hello Webcam, Microsoft Windows 11 pro x64 with 16 GB RAM, 512 GB PCIe SSD (main storage, user swappable), Sunlight Readable (Full HD LCD) + Touchscreen Stylus, US KBD + US Power cord, membrane backlit KBD, WIFI + BT, RS232 + VGA Port + 2<sup>nd</sup> LAN (RJ45) + Thunderbolt 4 or approved equal.

### **4. APPROVED EQUAL OR EQUIVALENT ITEMS**

- 4.1. Bidder must submit specification, cut sheets, and brochure data with the bid submission if bidding on an equal or equivalent item. Bidders must also include a company name, address, contact and contact telephone number of where the product is currently being utilized.
- 4.2. If the bidder is bidding an approved equal, they must first provide references for the exact make and model intended to be supplied. If bidding an alternate or approved equal, two copies of brochures, specifications, and any other pertinent information must be uploaded with bid in Bonfire.
- 4.3. In the event that an alternate is bid, the County of Rockland reserves the right to request a demonstration of the specific model bid. Failure to furnish the demonstration will render the bid, for that item, as non-responsive.

Any alterations to this document made by the Offeror may be grounds for rejection of the proposal, cancellation of any subsequent award, or any legal remedies available to the County of Rockland.

- 4.4. Any units not conforming to these specifications may be rejected, and it will be the responsibility of the manufacturer to conform to the requirements unless exceptions have been specifically cited by the bidder and acceptance made on the basis of the exceptions. Each bidder is required to respond to every requirement in this specification with the appropriate explanation of equipment when specified and supply all requested information with bids.
- 4.5. The County of Rockland will make the final determination on whether the equipment is considered an approved equal.

## **5. BID TABLE**

- 5.1. The Bid Table shall be completed, and every line filled in on the table.
- 5.2. Bidder shall submit pricing on all lines, if any items are left blank, the bid may be rejected.

## **6. AWARD**

- 6.1. Bid will be awarded in its entirety to the lowest responsive responsible Bidder meeting stated requirements of bid.

## **7. CONTRACT PRICE ADJUSTMENTS UPON RENEWAL**

- 7.1. The bid rates shall remain firm through the first contract period with no adjustments allowed. If the County exercises the 6-month option of the award, Contractor may submit a request for adjustment on the anniversary date of the contract. Any request for price adjustment(s) shall be submitted thirty (30) days in advance in writing to the Director of Purchasing. All price adjustments will be limited to the percentage increase in the CPI Index – All Urban Consumers for the preceding 6 months. The County reserves the right to reject any request for price increase deemed excessive.
- 7.2. CPI-Index - Consumer Price Index for All Urban Consumers as published by the Bureau of Labor Statistics of the United States Department of Labor or a successor or substitute index, appropriately adjusted.
- 7.3. Vendors shall submit a letter to the Director of Purchasing, during the term of this bid, addressing any **unscheduled price increases** from the manufacturers. This letter must include on the manufacturer's letterhead all information to support any unscheduled increase. Any increase authorized is at the sole discretion of the Director of Purchasing and shall be in writing.

## **8. SPECIFICATION**

- 8.1. Each vendor shall complete the minimum specification requirements contained in this bid package and submit with the bid response. Failure to complete this form may result in the rejection of the submission.
- 8.2. When bidding an alternative product, the bid submission must also include the product specifications for review.
