**SPECIFICATIONS**

**1. SCOPE**

1.1. The scope of this bid is to provide the latest improved model of a DJI Drones, accessories, and Paladin Watchtower software subscription as specified or approved equal for the Rockland County District Attorney’s Office. The drone will be used to survey various sites and must include all equipment, options, and accessories as noted in the specification pages of this bid. Equipment furnished by supplier must meet or exceed all requirements in specifications.

**2. GENERAL REQUIREMENTS**

2.1. The bidder represents that all equipment offered under this specification shall be new. USED, SHOPWORN, DEMONSTRATOR, PROTOTYPE, OR DISCONTINUED MODELS ARE NOT ACCEPTABLE.

2.2. The unit must be completely assembled and adjusted. All equipment including standard and supplemental equipment is to be installed and ready for continuous operation on delivery.

2.3. Vendor is to provide all operation manuals for drone and accessories surveillance equipment.

2.4. All parts not specifically mentioned, which are necessary for the unit, to be complete and ready for operation or which are normally furnished as standard equipment shall be furnished by the vendor. All parts shall conform in strength, quality, and workmanship to the accepted standards of the industry.

2.5. Bid responses must include copy of any licensing/subscription agreements to be considered.

2.6. Bids containing restrictions will not be acceptable unless Rockland County Purchasing Department deems that the restrictions conform to County of Rockland requirements.

2.7. The unit provided shall meet or exceed all Federal and State of NY laws, regulations, and standards in effect and applicable to equipment furnished at the time of manufacture.

2.8. Bidders shall furnish with the bid, or have on file with the County of Rockland, the latest printed literature and detailed specifications on equipment proposed. This literature is for information purposes only.

2.9. The vendor must have at least three (3) years’ experience in providing specialty unmanned aircraft.

2.10. **If a particular make and model is bid, everything that normally is provided with that make and model must be included regardless of whether the specification calls for the item or not.**

2.11. The drone and accessories must be delivered after it is completed according to the manufacturer’s pre-delivery inspection/service successfully. The equipment must be clean and ready for use upon delivery. All mechanical and electrical components shall be fully functional and operational.

2.12. Vendor is to supply on-line instruction for up to 12 months

2.13. A Manufacturers MSRP Price list is to be included with your bid in which all percentage discounts will be applied.

2.14. Percent Discount is to be entered as a whole number **EX:10%= 0.10**

### 3. PRICE

3.1 All items listed must be completely filled in or the bid will be considered unresponsive and rejected. All prices quoted shall be firm and fixed for the length of the contract with the exception of the Contractor offering additional discounts to the bid prices if they become available from the manufacturer. The contractor is required to pass along all additional discounts or price concessions that may be during the term of this contract.

### 4. CONTRACT MWBE

- 4.1 MWBE goals may have been set for this project. Contractors shall employ good faith efforts to provide MWBE participation.
- 4.2 Many of the orders placed for this type of equipment are processed with New York State or other Grant funds. Therefore, respondents should indicate how they intend to meet the 30% NYS MWBE Grant requirements and if their firm is currently on the list. If so, please provide a current MWBE certificate with your bid. The County encourages submissions by certified Minority and/or Women-Owned Business Enterprises.

### 5. BRAND NAME

- 5.1. **The use of a brand name is for the purpose of describing the standard of quality, performance, and characteristics desired and is not intended to limit or restrict competition.**

### 6. EQUIVALENT OR APPROVED EQUAL

- 6.1. If submitting an alternate or approved equal machine, bidder shall submit two (2) copies of brochures/catalogs, specifications, and any other pertinent information, with the bid. This information should be attached directly behind the detailed specifications.
- 6.2. In the event that an alternate is bid, the County of Rockland reserves the right to request a demonstration of the specific model bid. Failure to furnish the demonstration would render the bid for that item as non-responsive.

### 7. NOTES

- 7.1. ***Do not make any revisions or delete any part of the Detailed Specifications. If there are any revisions and/or deletions of the Bid Documents the bid will be rejected as being non-Responsive. All questions pertaining to this Solicitation MUST be submitted in writing (see page 23 of the Bid Specifications).***
- 7.2. ***All Detailed Specifications allow submission of approved equal products. Determination of whether an item is an approved equal is the sole determination of the County of Rockland. Determination on an approved equal will be made during the evaluation process.***

**8. WARRANTY**

8.1. The manufacturer’s standard warranty is to apply. However, it must be not less than one year, including replacement of parts and labor. If unit is not able to be repaired during the warranty period, full replacement must be made.

**9. CONTRACT PRICE ADJUSTMENTS UPON RENEWAL**

- 9.1 The County recognizes this product has a price component that may have a commodity with changing costs. The Contractor/Supplier may request a Price Adjustment no more frequently than after the first year on renewal of this contract. A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (i.e., commodity increases), the current pricing, and the requested revised pricing.
- 9.2 The County will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County will provide a written explanation in support of the decision.
- 9.3 The Director of Purchasing may use available indexes (e.g., CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that exceeds 5% will not be approved unless very unusual and significant changes have occurred in the industry.
- 9.4 In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices/pricing that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation

**10. AWARD**

- 10.1. Award shall be made by Section to the lowest responsible bidder meeting the stated requirements in each section and in the best interest of the County. Bidder must bid on all lines in a section to be awarded that section.
- 10.2. The County of Rockland’s District Attorney’s Office along with Purchasing Department will determine if any alternate models bid will be suitable for the drones intended purpose and award will be made along with their recommendation.
