SPECIFICATIONS

1. SCOPE

1.1. The County of Rockland is seeking to purchase an emulsion additive for road resurfacing on an as needed basis. This specification applies to incorporating performance enhancing additive materials into micro-surfacing. These performance additives are intended to augment, not replace, conventional micro-surfacing materials as specified by the New York State Department of Transportation (NYSDOT) for use in New York State Office of General Services (NYSOGS) state-wide contracts. Accordingly, price proposals shall include only the additive materials and be in addition to the unit prices for conventional materials as specified.

2. USAGE

2.1. The County of Rockland Highway Department estimates approximately 2,500 tons of Product will be needed.

3. MATERIALS

3.1. **Highly polymer modified** micro surfacing shall utilize an asphalt emulsion formulated from a PG 58-28 base which has been modified with a 6% SBS polymer loading (by weight of binder before emulsification). The polymer modification of the base asphalt binder shall occur in advance of and separate from the emulsification process. The special polymer shall be a styrene and butadiene di-block copolymer thermally or chemically cross-linked in the asphalt binder during the blending process such that it is fully reacted. The resultant emulsion shall yield a softening point not less than 170°F and meet the following property specifications, and the emulsion supplier shall furnish a certificate of compliance for the material.

3.3. The micro-surfacing emulsion shall be protected from freezing, not overheated, and maintained in the temperature range of 50-120 degrees Fahrenheit until ready for application. During transfer and handling of the emulsion, care should be taken to avoid excessive pumping with high shear pumps.

4. CONSTRUCTION DETAILS

4.1. **Micro-Surfacing Performance Additives** shall be blended into the PG58-28 base asphalt binder before it is emulsified and shipped to the job site. The addition of these additives will exceed what is required within the NY OGS and shall increase the minimum softening point of the asphalt binder from 135°F to 170°F, shall have an elastic recovery of at least 80%, and shall have a maximum Jnr of 0.5. (The elastic recovery and Jnr shall be determined by the Modified Stress Creep Recovery (MSCR) test.) Certification from the supplier shall be provided to insure inclusion of the performance additives with PG base binder before the emulsification process.

5. MEASURMENT AND PAYMENT

5.1. **Micro-Surfacing Performance Additives** will be paid for at the proposed unit prices per ton of micro surfacing complete and shall be in addition to the NYSOGS contract unit prices. Daily tons shall be determined utilizing the revolution counters affixed to the calibrated equipment, with such counts and calculations submitted to the Owner daily.

6. TERM OF CONTRACT

6.1. The term of the contract specified herein will be for one year. The contract may be extended, with the mutual consent of the Owner, and the successful Supplier for one additional one-year period.

7. CONTRACT PRICE ADJUSTMENTS UPON RENEWAL

7.1. The proposed pricing must remain firm through the first contract period with no price adjustments allowed. If the County exercises any of the option years of the contract, Contractors may submit a request for adjustment on the yearly anniversary date of the contract. Any request for price adjustment(s) must be submitted thirty (30) days in advance in writing to the Director of Purchasing. Any and all price adjustments will be limited to the percentage increase in the CPI Index – All Urban Consumers for the preceding 12 months. The County reserves the right to reject any request for price increase deemed excessive.

8. AWARD

8.1. This bid will be awarded to the lowest responsible bidder meeting all the stated requirements.
