SPECIFICATIONS

1. SCOPE

1.1. The scope of this bid is to provide a crisis response throw phone system. The system shall provide crisis negotiation/response teams with three different communication options including independent throw phone communications, enhanced land line communications, and cellular phone link communications.

2. REQUIREMENTS

- 2.1. All items must be as specified or approved equal or equivalent.
- 2.2. Bids containing restrictions will not be acceptable unless the County of Rockland Purchasing Division deems the restrictions conform to County of Rockland requirements.
- 2.3. The unit shall be completely assembled and adjusted, and all equipment including standard and supplemental equipment shall be installed and the unit made ready for continuous operation.
- 2.4. All parts not specifically mentioned which are necessary for the unit to be complete and ready for operation or which are normally furnished as standard equipment shall be furnished by the vendor. All parts shall conform in strength, quality and workmanship to the accepted standards of the industry.
- 2.5. All prices bid must include freight.
- 2.6. Bidder must be a Factory Authorized Dealer and Service Provider for the Products they are bidding.
- 2.7. The bidder shall be certified/trained by the manufacturer to work on the equipment being bid.
- 2.8. The vendor must provide a copy of the warranty with their bid and all discounts must be firm and fixed for the specified contract period.
- 2.9 The percentage Discount is to be entered as a whole number **EX:10%=0.10** on the proposal pages.
- 2.10 Successful vendors will be required to notify the Division of Purchasing of any revisions to price lists and to supply updated lists. Inasmuch as the price list in the possession of the County of Rockland will be the governing copy, it shall be the responsibility of the successful vendor to ensure that the current price list is forwarded to the Purchasing Division for review and approval

3. BRAND NAME

3.1. The use of a brand name is for the purpose of describing the standard of quality, performance, and characteristics desired and is not intended to limit or restrict competition.

4. EQUIVALENT OR APPROVED EQUAL

- 4.2. If submitting an alternate or approved equal machine, bidder shall submit two (2) copies of brochures, specifications and any other pertinent information, with the bid. This information should be attached directly behind the detailed specifications.
- 4.3. In the event that an alternate is bid, the County of Rockland reserves the right to request a demonstration of the specific model bid. Failure to furnish the demonstration would render the bid for that item as non-responsive.

5. FREIGHT DEFINITIONS

5.1. F.O.B. Destination / Freight Prepaid & Allowed

Ownership passes to the County when the carrier delivers the product to the delivery point specified by the Purchase Order. (Vendor owns product in transit) The County is not billed. Vendor pays freight charges.

6. CONTRACT PRICE ADJUSTMENTS UPON RENEWAL

- 6.1. The bid rates shall remain firm through the first contract period with no adjustments allowed. If the County exercises any of the option terms of the award, Contractors may submit a request for adjustment on the yearly anniversary date of the contract. Any request for price adjustment(s) shall be submitted thirty (30) days in advance in writing to the Director of Purchasing. Any and all price adjustments will be limited to the percentage increase in the CPI Index All Urban Consumers for the preceding six months. The County reserves the right to reject any request for price increase deemed excessive.
- 6.2. CPI-Index Consumer Price Index for All Urban Consumers as published by the Bureau of Labor Statistics of the United States Department of Labor or a successor or substitute index, appropriately adjusted.
- 6.3. Vendors shall submit a letter to the Director of Purchasing, during the term of this bid, addressing any <u>unscheduled price increases</u> from the manufacturers. This letter must include on the manufacturer's letterhead all information to support any unscheduled increase. Any increase authorized is at the sole discretion of the Director of Purchasing and shall be in writing.

7. DETAILED SPECIFICATIONS – NOTES

7.1. All Detailed Specifications allow submission of approved equal products. Determination of whether an item is an approved equal is the sole determination of the County of Rockland. Determination on an approved equal will be made during the evaluation process.

8. CONFIDENTIALITY AND SECURITY

- 8.1. This document or any portion thereof, may not be used for any purpose other than the submission of a bid.
