- 3. All purchases shall be subject to audit and inspection by the other political subdivisions and Rockland County non profit agencies for which the purchase was made.
- 4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
- 5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non profit agencies authorized to use New York State's contracts, if called upon to do so. SPECIFICATIONS

1. PURPOSE

1.1. The purpose of this bid is to solicit proposals from qualified vendors to provide reproduction and printing services for several County of Rockland's departments and agencies. Services will support various governmental functions and must meet high standards of accuracy, confidentiality, and timeliness.

2. SCOPE OF WORK TO INCLUDE

- 2.1. High-volume document reproduction (black & white and color)
- 2.2. Wide-format printing (e.g., maps, architectural drawings, blue prints)
- 2.3. Binding and finishing (e.g., stapling, comb binding, saddle stitching)
- 2.4. Collating, folding, and booklet-making
- 2.5. Scanning and digitization of paper documents
- 2.6. Confidential shredding of excess/obsolete documents
- 2.7. Pickup and delivery service to government offices (as required)

3. **REQUIREMENTS**

- 3.1. Unless otherwise specified herein, the contractor is to furnish all materials, tools, equipment, manpower and consumables needed to complete the work.
 - 3.2. Price to include pick-up and delivery of all items from and to various locations listed on the bid. Pick-up and deliveries shall be made between the hours of 9:00 AM and 4:00 PM, Monday through Friday excluding holidays observed by the County of Rockland.
 - 3.2.1.Contractor shall provide FTP information for electronic transmission of files to be output. FTP transmission will be used when feasible but will not be mandatory.
- 3.3. Contractor shall pick up within eight (8) business hours after the telephone or email request and receipt of Purchase Order. Vendor must not provide service without an official purchase order receipt from County of Rockland. The completed job shall be returned within a maximum of 48 hours after receipt of originals. Any rework required, due to vendor error, shall be corrected and returned within four hours after submission at no additional cost to the County.
 - 3.4. Contractor may be required, on occasion, to make an overnight delivery to a second source and return originals to the County of Rockland.
 - 3.5. Contractor may be required, on occasion, to maintain originals at contractor's facility.
 - 3.6. Quantities are estimated for one-year usage and may vary for actual orders. Quantities may be more or less.
- 3.7. Errors or reprints due to vendor faults must be corrected at no cost.

4. VENDOR QUALIFICATION

5. AWARD

5.1. Award will be made to the most responsive responsible bidder meeting all qualifications and requirements as a whole for all items.

6. PRICING STRUCTURE

- 6.1. Pricing to be provided by quantity breaks as specified in bid Proposal Pricing sheets.
- 6.2. Items with specified scope of service but are not listed on the Proposal Pricing sheet will be ordered after obtaining a formal quotation by the awarded vendor for example County of Rockland will obtain a quotation for a photocopy for a size larger than listed on proposal sheet or a Volume higher than listed on the proposal sheet.
- 6.3. Awarded Vendor must not quote under this bid an out of scope service for example vendor **can not** provide Graphic design services or create Artwork for a new logo etc.

7. Fixed Pricing with Tariff Adjustment Clause

7.1. Pricing shall be firm for the initial contract term; however, should tariffs imposed by the U.S. government materially change, the awarded contractor may request a price adjustment. Such requests must include official documentation verifying the tariff change and will be subject to County approval.
