4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non-profit agencies authorized to use New York State's contracts, if called upon to do so. The County, however, will not be responsible for any debts incurred by the participants pursuant to this or any other agreement.

1. SCOPE

- 1.1. The County of Rockland is seeking to establish a contract for the services of testing laboratories to perform the Construction Material Testing requirements for all County of Rockland Facilities locations. Sites may be located at the Dr. Robert L. Yeager Health Center, Pomona, N.Y., The New City Government Center, New City, N.Y., the Fire Training Center, Pomona, N.Y., Rockland Community College Campus, Suffern, N.Y., Rockland County Sewer District #1, and any other County owned properties or County run projects.
- 1.2. The term of this contract will be one year from the date of the award with the option to renew for three additional one-year terms. Firms shall submit prices for each identified service as classified. An estimated quantity of the required service, which may be required in a one-year time frame, has been established which will be used to compare individual bids. These estimated quantities are for purposes of bid comparison only. Actual quantities of each service may vary more or less, and none of the estimated quantities are guaranteed to be needed.
- 1.3. Vendor is to conduct all tests using licensed or certified field/laboratory personnel and in accordance with the latest ASTM and ACI guidelines. Testing laboratories shall be accredited to perform any/all procedures required by the latest ASTM and ACI guidelines.

2. MATERIAL TESTING REQUIREMENTS

Scope of services shall include classification of proposed on-site and borrowed soils to verify that soil compaction complies with specified requirements, concrete testing, field technician services for bituminous paving, masonry, steel, and reinforcing steel, field and laboratory testing including report preparation for all testing as follows:

Storing the samples, if necessary, delivery of the samples to the Geotechnical Engineer and final disposal of the samples are also to be included within the quoted price.
