SPECIFICATIONS

1. SCOPE

- 1.1. The scope of this bid is to furnish and deliver articles of clothing for incarcerated individuals at the Rockland County Correctional Center. Clothing on the proposal pages may be bid on -line by line basis and not all lines need to be bid on. However, lines within a specific group must be bid on in order to be awarded that group. (See Section #9).

2. REQUIREMENTS

- 2.1. Due to supply chain and marketplace conditions, note revised duration and pricing adjustments in section #3
- 2.2. Receipt Confirmation Form must be returned within five working days of receiving the bid. Do not send with bid.
- 2.3. Statement of Required Disclosures, Representations and Certifications must be completely filled out, notarized, signed, and returned with bid.
- 2.4. Supplier must have three (3) years' experience in supplying specified products and Certificate of Experience form must be completed, signed, and returned with bid.
- 2.5. All Lines in specific groups shall be priced or bid will be considered non-responsive.

reasonable. Typically, a Price Adjustment that **exceeds 5%** in quarter will not be approved unless very unusual and significant changes have occurred in the industry.

- 3.3 In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation.

4. INVOICES/PACKING SLIPS
