## **SPECIFICATIONS**

## 1. Scope of Work

- 1.1. The Rockland County Sewer District #1 (RCSD#1) is seeking monthly rental prices for (1) 1500KW 480V Generator and associated electrical cables as specified for the RCSD#1's Main Plant at 4 Route 340, Orangeburg, NY. Awarded supplier shall provide full electrical hook-up and phase verification services.
- 1.2. The word "Monthly" shall be understood as (1) continuous 28-day period for billing purposes.
- 1.3. Contractor providing full electrical work and phase verification service must be a Rockland County Licensed Electrician. This may be subbed out by the generator rental company responding to this bid.
- 1.4. The maximum expected amp draw will be 1,600 amps.
- 1.5. Awarded supplier shall be responsible for providing all labor, tools, materials, and equipment necessary.
- 1.6. Bidder shall submit insurance and new vendor from as specified on the bidders check list.

## 2. Scope of Supply

- 2.1. Suppler shall supply the following:
  - (1) 1500KW 480V Generator, 3 phase, Deisel powered.
  - (6) Sets of cables that are 150 feet EACH, bearing FEMALE ENDS on the load side.
  - Fuel Tank Capacity 1,250 Gallons or greater.
  - On-site delivery and off-loading.
  - Full site mobilization and equipment placement.
  - Final hook-up by a Rockland County licensed electrician.
  - Testing, commissioning, and phase verification.
  - Full site de-mobilization and equipment removal/pickup.
  - Full maintenance services and repairs as needed.

## 3. Pricing

- 3.1. Supplier shall enter pricing for each:
  - Delivery & Full Mobilization.
  - Hook-Up and Phase Verification by a Rockland CO. Licensed Electrician.

## 4. Mobilization and Demobilization

- 4.1. Awarded supplier shall be responsible for full mobilization which includes:
  - Delivery of (1) 1500KW 480V Generator.
  - Delivery of (6) 150 Foot Cables, Female End on the load side.
  - Full Set-Up
  - Electrical Hook-Up which includes connection from the genset to the splice box connections as show in the picture attached to this bid.
  - Phase Verification
  - Start-Up and Testing to confirm full functionality of generator.
- 4.2. Awarded supplier shall be responsible for full demobilization which includes:
  - Coordinate shutdown procedures with facility personnel to ensure safe power down.
  - Disconnect generator from all electrical loads and isolate power.
  - Remove generator from its temporary placement area.
  - Remove all the associated cables.

## 5. Schedule

- 5.1. Work must be completed within 5 days from notice to proceed.
- 5.2. Coordination with site personnel is required at least 48 hours in advance Delivery and Pick-up.
- 5.3. The County of Rockland reserves the right to nullify this contract at any time when it has been determined that the rented generator is no longer needed.

## 6. Availability

- 6.1. Supplier shall be responsible to:
  - Provide 24/7 emergency service staff.
  - Provide all preventative maintenance services in accordance with the manufacturer's maintenance schedule.

## 7. Award

7.1. This bid shall be awarded to the lowest responsive, responsible bidder.
