 - 5.3.1 A minimum of two (2) references providing similar services to municipalities, commercial and/or industrial load accounts.
- 5.4 The references must include the municipality name and complete contact information.

- 5.6 Conditional Bids will not be accepted.

- This is a cooperative IT Natural Gas purchase. The County is seeking one (1) aggregate, weighted average price for both agencies, for each pricing option requested.
- 6.2 This is an interruptible service natural gas purchase; the flow start date for both accounts will be the meter read on or after January 1, 2026.
- 6.3 The County is seeking NYMEX + Basis pricing to the City Gate for the requested terms.
- 6.4 The County requests IT Natural Gas Bids for the following terms: Twelve (12) month, Twenty-four (24) month, Thirty-six (36) month
- 6.5 The County requests pricing for 100% Swing Tolerances for all requested pricing terms.
- 6.6 Pricing shall be stated for IT Natural Gas Supply Service only.

6.7 **Pricing Option 1** must be based on a Basis only rate per dekatherm, including any Orange & Rockland Utility line loss charges to the City Gate – and 100% Swing Tolerance- 12 month term.

- 6.8 **Pricing Option 2** must be based on a Basis only rate per dekatherm, including any Orange & Rockland Utility line loss charges to the City Gate and 100% Swing Tolerance- 24 month term.
- 6.9 **Pricing Option 3** must be based on a Basis only rate per dekatherm, including any Orange & Rockland Utility line loss charges to the City Gate and 100% Swing Tolerance- 36 month term.
- 6.10 **Pricing Option 4** must be based on an All-In City Gate rate (Basis plus NYMEX) per dekatherm, including any Orange & Rockland Utility line loss charges to the City Gate and 100% Swing Tolerance- 12 month term.
- 6.11 **Pricing Option 5** must be based on an All-In City Gate rate (Basis plus NYMEX) per dekatherm, including any Orange & Rockland Utility line loss charges to the City Gate and 100% Swing Tolerance- 24 month term.
- 6.12 **Pricing Option 6** must be based on an All-In City Gate rate (Basis plus NYMEX) per dekatherm, including any Orange & Rockland Utility line loss charges to the City Gate and 100% Swing Tolerance- 36 month term.
- 6.13 Grossing of volumes to account for any losses to the City Gate is strictly prohibited.
- 6.14 All Basis pricing must include a "trigger option" permitting the customer to lock in a fixed NYMEX natural gas rate at any time during the service term.
- 6.15 Each agency shall contract and be billed separately for its IT Natural Gas supply.
- 6.16 Billing method is Dual Bill.

7. PAYMENT TERMS

- 7.1 Payment terms are **Net 30**.
- 7.2 In submitting a Bid, the bidder acknowledges that it waives any and all claims and causes of action against all participating County of Rockland Agencies, the members of NORESCO LLC or any of their officers, directors, representatives, members, employees, principals, consultants and agents, on the basis of the historical usage that the bidder may have relied upon. The Agreement will not be on a "take-or-pay" basis.

8. CONTRACT QUANTITIES

Contract Quantities shall be determined by historical consumption patterns for each account and shall be mutually agreeable to both the contracting agency and the Awarded ESCO.

The service start date for all IT natural gas accounts must be the meter read on or after January 1, 2026.

Each Agency must contract with and be billed separately by the Awarded ESCO for its natural gas supply.

The General Terms & Conditions in Appendix "A" are in addition to the ESCO's standard Terms & Conditions. Any contract awarded must be executed on the ESCO's New York State Sales Agreement, pending approval of contract language by the County Attorney, as stated in the RFB Specifications.

10. AVAILABILITY OF FUNDS

Pursuant to New York State Law any contract(s) resulting from this Bid shall be subject to the annual availability and appropriation of sufficient funds.

11. BID EVALUATION AND AWARD

Bids will be evaluated by the County's Energy Consultant and Awards shall be made to the lowest responsible bidder meeting the requirements of the Bid.

It is the intention of the County to notify the winning bidder of award within 3 hours of the bid opening.
