3. All purchases shall be subject to audit and inspection by the other political subdivisions and Rockland County non profit agencies for which the purchase was made.
4. No officer, board or agency of a county, town, village, or school district shall make any purchase through the County when bids have been received for such purchase by such officer, board or agency, unless such purchase may be made upon the same terms, conditions and specifications at a lower price through the County.
5. All Bidders shall be on notice that as a condition of the award of a County contract, the successful bidder shall accept the award of a similar contract with any other political subdivision in New York State and Rockland County non profit agencies authorized to use New York State's contracts, if called upon to do so. ## **SPECIFICATIONS**

### **1. SCOPE**

- 1.1. The scope of this bid is to furnish and deliver specified articles of clothing for incarcerated individuals at the Rockland County Correctional Center. Bidders must bid on all lines to be considered for this award.
- 1.2. Prices submitted must include printing 'RC JAIL' in 3" white letters on the back of the shirts only.

### **2. REQUIREMENTS**

#### **2.1. SHIRTS- V-NECK with pocket (Orange)**

- 2.1.1. Polyester/ Cotton with a minimum weight of 7.5 oz.
- 2.1.2. 3 needle felling stitching on all seams for extra strength and durability
- 2.1.3. Bar tacks to reinforce stress points
- 2.1.4. Bleach-resistant dye that stands up to institutional laundry and bleaching with minimal shade loss
- 2.1.5. Industrial fabric finish that resists creases
- 2.1.6. One double needle stitched breast pocket
- 2.1.7. Sizes up to 8XL
- 2.1.8. Printing on the back of the shirts must be included in the price of all shirts.

#### **2.2. TROUSERS -NO pockets (Orange)**

- 2.2.1. Polyester/ Cotton with a minimum weight of 7.5 oz.
- 2.2.2. 3 needle felling stitching on all seams for extra strength and durability
- 2.2.3. Bar tacks to reinforce stress points

- 3.4. A Manufacturers product specification sheet must be submitted with the bid otherwise bidder may be deemed non-responsive. Specification sheet must confirm style meets the requirements.
- 3.5. A return label must be sent for all non-awarded styles to be returned at no cost to the county.
- 3.6. If a return label is not included, the samples will be discarded.
- 3.7. Awarded styles will be kept in the purchasing department for reference.

#### **4. BRAND NAME**

- 4.1. The Brand name listed is not meant to limit competition.
- 4.2. The use of a brand name is for the purpose of describing a standard of quality, performance, and characteristics desired and not intended to limit or restrict competition.
- 4.3. Alternates must be submitted for evaluation and approval prior to the bid closing date.
- 4.4. The Rockland County Correctional Facility will have final say on what is an approved equal.

#### **5. DELIVERY**

- 5.1. All prices must be FOB destination prepaid and allowed.
- 5.2. Delivery must be made within 30 days of receipt of order unless an alternate date is agreed to by the Rockland County Correctional Facility.
- 5.3. Lead times must be submitted in the column on the bid table.

#### **6. QUANTITIES/SIZES/SUBSTITUTES**

- 6.1. All quantities shown are estimated.
- 6.2. The county has a current need for 24 each of the following sizes: L, XL, 2XL, 3XL, 4XL in both tops and bottoms
- 6.3. All other orders will be on an as needed basis.
- 6.4. Bidder must send size chart for all items with bid indicating numbers or letters. If letters are used, bidder is to indicate corresponding number size.
- 6.5. No substitutes are allowed. If an item is discontinued during the bid period, a replacement may be offered at the same contract price. Such a replacement must be approved by the correctional facility prior to shipping.
- 6.6. Exchange for size on non-altered styles. Should incorrect size be sent or should item not fit properly, exchange for size shall be permitted. There shall be no return or restocking charges. Item being returned must not be worn (except for try on) and must be returned in the condition it was received.

#### **7. EXPERIENCE**

- 7.1. Bidders must have three years of experience providing correctional Facility apparel
- 7.2. Bidders must submit the Certificate of Experience form listing a minimum of three agencies they are currently providing the submitted apparel to. References will be checked. An email address must be provided.

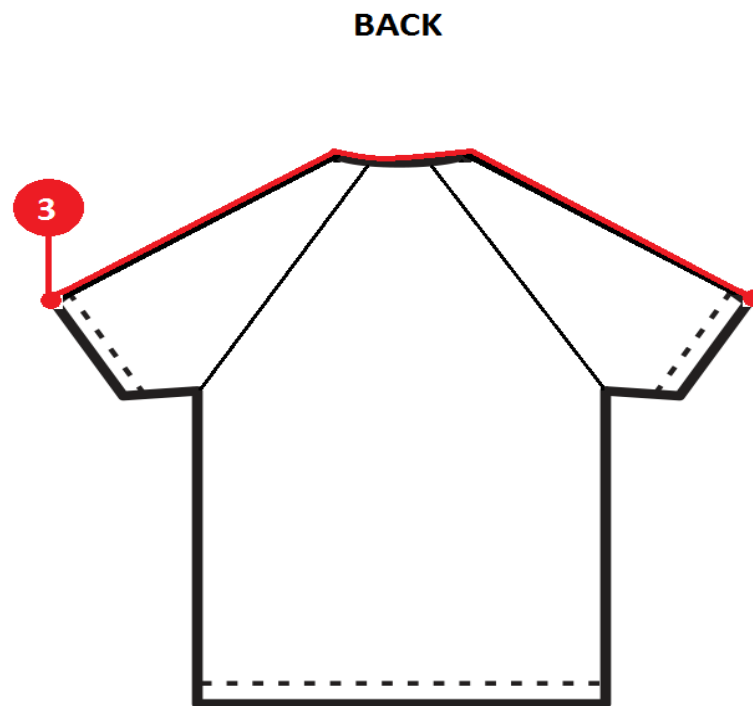
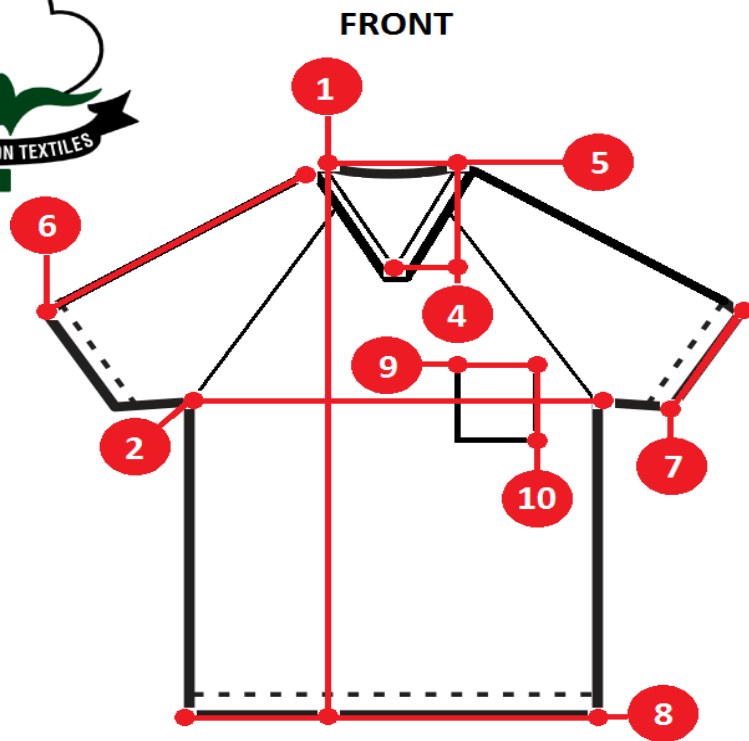

## 8. PRICE ADJUSTMENT

- 8.1. The County recognizes these products have a price component that may be a commodity with changing costs. The Supplier may request a Price Adjustment no more frequently than once per contract year. A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (i.e., commodity increases), the current pricing, and the requested revised pricing
- 8.2. The County will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County will provide a written explanation in support of the decision. The Director of Purchasing may use available indexes (e.g., CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that **exceeds 5%** in quarter will not be approved unless very unusual and significant changes have occurred in the industry.
- 8.3. In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation.

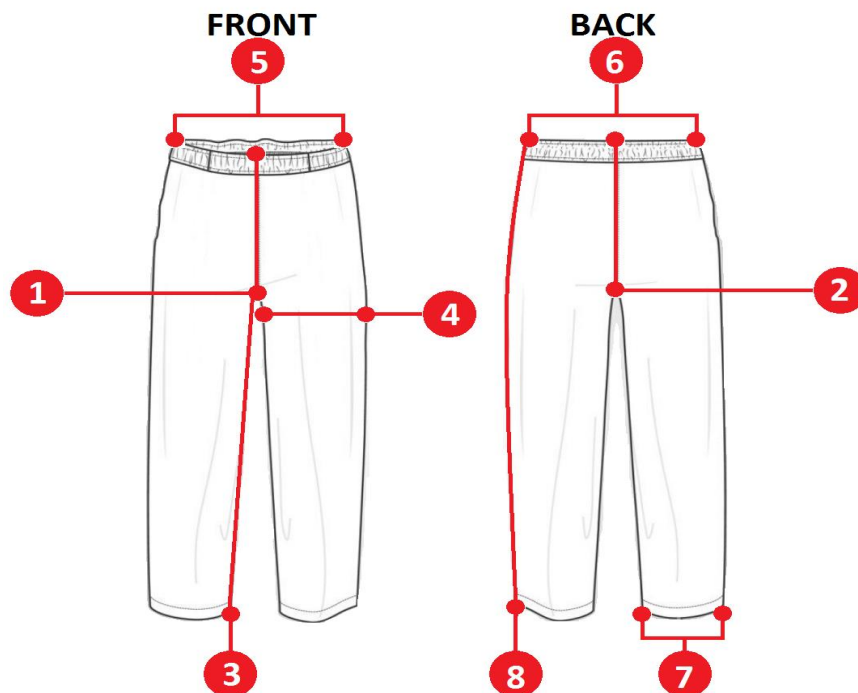
