OVERVIEW

Rockland County issued an RFP that resulted in the selection of providers of Engineering Services to be placed on one or more Qualified Suppliers Lists to provide services on an as needed basis by the Rockland County Sewer District #1, the Rockland County Highway Department including the Rockland County Drainage Agency and the Department of General Services Facilities Management Division.

CONTRACTING PROCESS

- Projects valued up to \$35,000.00 may be assigned directly by the user department with a firm on the Qualified Suppliers List by submitting a DCE-100 Contract Request.
 - ALL FIRMS WITH A PHYSICAL ADDRESS IN ROCKLAND COUNTY WILL BE INVITED TO SUBMIT A QUOTE FOR ALL CONTRACT OPPORUNITIES.
 - o The County will enter into separate contracts for each project. Change orders to the original contract amounts will be limited based on the original value of the contract. A contract assigned to a firm on the Qualified Suppliers list, with an original value of under \$35,000, will not be permitted to exceed the \$35,000 limit. It is anticipated or should reasonably be known that the contract may need to be modified and exceed the \$35,000 competitive quotes as noted below shall be obtained.
- Projects valued at \$35,000.00 up to \$100,000
 - ALL FIRMS WITH A PHYSICAL ADDRESS IN ROCKLAND COUNTY WILL BE INVITED TO SUBMIT A QUOTE FOR ALL CONTRACT OPPORUNITIES.
 - The user department shall obtain a minimum of five (5) quotes from firms listed on the Qualified Suppliers List. Each Department will be required to advise the Purchasing Division, in writing, as to the project scope and firms to be solicited prior to soliciting proposals and to maintain records to show which firms were contacted for each contract opportunity and to ensure that all firms are offered an equal opportunity throughout the year to respond to the Department's Request for Quotations.

Change orders to the original contract amounts will be limited based on the original valve of the contract.  - o The user department shall submit to the Purchasing Department a detailed scope of work for the services needed. The Purchasing Department shall invite all firms (qualified to perform the scope of services) that appear on the Qualified Suppliers List to submit a quotation and proposal.
 - The County will enter into a separate contract for each project by submitting a DCE-100 contract request. Change orders to the original contract amounts will be limited based on the original valve of the contract. A contract awarded based on quotes received by the Purchasing Division, with an original contract valve of \$100,000 to \$250,000 will not be permitted to exceed \$250,000.

 - o For projects in excess of \$250,000, a project specific RFP shall be issued.

Question 2

Detailed Response (pg. 14 under Proposal Response Format) asks for a "a specific point-by-point response, in the order listed, to each requirement in the RFP. Where is this information located?

Response 2

This information is located in the Proposal Requirements and Company Qualifications for each agency. A detailed response of the Organizations ability to meet the requirements of each agency should be provided.

Question 3

Section 18 – Liquidated Damages

This section references "Schedule E" which was not included with the RFP documents. Will Rockland County consider removing this provision? The clause appears to be for construction contractors, not AE firms.

Response 3

There is no reference to Liquidated Damages in the Request for Proposal.

Question 4

We didn't see any specific request for Section IV: Protected Information in the RFP; can you confirm whether or not financial statements, or any other information, should be included in this section?

Response 4

There is no specific request for protected information. If you are however submitting any information that you deem to be protected information, then it should be submitted in this section only in a redacted version.

Question 5

In Addendum 2, Response 2, it states that "proposals must include a minimum of 3 current projects and 2 past projects," does that mean that the 10 projects are no longer needed for this submission? in which case do we use the 10 or 5 projects.

Response 5

Each proposal shall include a description of at least ten (10) of the firm's most relevant projects in chronological order, most recent first. The emphasis should be on relevant prior experience and accomplishments recognized for design excellence and supported by reference recommendations.

Question 6

Since we can submit one proposal for all agencies do, we to provide 10 projects per agency or a total of the proposal (all agencies)

Response 6

Yes, as long as they meet the requirements outlined in the RFP.

Question 7

In the case that 10 projects are needed do we submit a past & present form for each project for prime and sub?-Or just primes are required to send this?

Response 7

Prime only.

Question 8

Would it be possible to obtain an extension for this submission.

Response 8

Unfortunately, we cannot extend the submission deadline.

Question 9

Should relevant projects only be written on the "Past & Present Performance Information form" and should these forms be included within the technical proposal?

Response 9

Yes, along with the experience statement.

Please note the following changes to the project background on pages 4-5, paragraphs 3&4 of the Request for Proposal.

The Qualified Suppliers List will be used for assigning work valued up to \$75,000 or less, quoting work valued over \$75,000-\$150,000 (a minimum of three written proposals shall be obtained by the using agency from firms on the QSL, and for quoting work valued over \$150,000 - \$250,000 (proposals obtained by the Purchasing Division by contracting all firms on the corresponding QSL for that agency). For projects in excess of \$250,000, a separate project specific Request for Proposal shall be issued.

The County will enter into separate contracts for each project. Change orders to the original contract amounts will be limited based on the original value of the contract. A contract assigned to a firm on the Qualified Suppliers list, with an original value of \$75,000 or less, will not be permitted to exceed the \$75,000 limit. A contract awarded based on quotes received from the user agency with an original contract over \$75,000-\$150,000, will not be permitted to exceed \$150,000. A contract awarded based on quotes received by the Purchasing Division, with an original contract value over \$150,000.00 to \$250,000 will not be permitted to exceed \$250,000.
