## **SPECIFICATIONS**

## 1. **SCOPE**

- 1.1. The County of Rockland is seeking pricing for offset printing services. The Finished product will be either two-color brochures or multi-color brochures. Assume full bleeds when submitting pricing.
- 1.2. The County of Rockland will order brochures on an as needed basis in quantities listed in the attached Bid Proposal Page. The primary user of this contract will be the Rockland County Department of Public Transportation; however, other County of Rockland departments are authorized to use this contract under the terms and conditions associated with this contract. All orders will require written approval prior to production.
- 1.3. Bidder shall submit a sample of a brochure printed on 60# white opaque **with bid** (Refer to the Bidders Check List on page 2).
- 1.4. 60# white opaque stock to have opacity of 93 or greater.
- 1.5. Brochures are to be printed and folded to the following sizes. Paper sizes and original artwork being provided will include four (4) size and fold types.
  - 1.5.1 Letter: 8.5" x 11" Tri-Fold
  - 1.5.2 Letter: 8.5" x 11" Half Fold, Then Tri-Fold
  - 1.5.3 Legal: 8.5" x 14 Double Parallel Fold
  - 1.5.4 Tabloid: 11" x 17" Half Fold, then Tri-Fold
- 1.6. Forward all electronic copies of artwork for written confirmation to designated department contact. The contractor shall receive final approval, in writing, for printing only after artwork is approved by the designated department contact requesting brochures.
- 1.7. The contractor shall provide complete delivery of the requested order within three (3) weeks form receipt of a purchase order.
- 1.8. The County reserves the right to inspect the facility and equipment to ensure the contractor can meet the requirements of the bid.

## 2. TERM

2.1. Pricing to be valid for a one-year period with option to renew for two (2) additional 1-year periods pending mutual agreement between the County and the contractor.

## 3. **REQUIREMENTS**

- 3.1. Bidder shall complete and submit the Certification of Experience form (see form attached).
- 3.2. Bidder shall complete and submit a list of company owned and/or leased equipment (see Certificate of Equipment form).

#### 5. PRICING

- 5.1. Pricing is to be submitted for the following material in accordance with the specifications and the proposal pages.
- 5.2. Pricing to represent all costs, including but not limited to, proof, prep, plating, printing, inside delivery and any other outside cost.
- 5.3. The County of Rockland will not approve payment for overruns.
- 5.4 Pricing to be FOB Destination, inside delivery to various locations throughout the County of Rockland, with a single destination for each order.

#### 6. PACKAGING

- 6.1. Brochures for the Rockland County Department of Public Transportation shall be delivered in boxes measuring approximately 12"H x 9'W x 12"D.
- 6.2. Each box shall have the Bus Route number, quantity, and a sample affixed to the outside

## 7. **DELIVERY**

- 7.1. Delivery shall be during business hours (Monday through Friday, 9:00am to 5:00pm).
- 7.2. Boxes shall be transported inside of the building to which they are being delivered.
- 7.3. Advanced notification of delivery shall be given at least one day prior.
