Description

This contract has been established to provide High Octane Gasoline and Diesel fuel for Westchester County Patrol Boats/Vessels on an as-needed basis.
This contract is extendable to municipalities upon mutual consent between the municipality and the awarded vendors. Municipalities are responsible for their own bills.

This contract has been awarded to two suppliers, one on the Westchester side of the Hudson River and one on the Rockland/Orange side of the Hudson River.

This contract may be renewed/extended upon mutual consent, in writing, prior to the expiration date, for the same price agreement, terms and conditions as set forth in RFB-WC-16063 for up to four (4) additional one year periods.

Fuel for Marine Patrol Boats

It is the intent of Westchester County to establish an agreement for the purchase of high octane fuel to be used for Westchester County Police patrol boats. Contract agreement will be for one (1) year from date of award and may be renewable for an additional four (4) terms, each term being one year in duration, with the same pricing structure, terms and conditions as set forth herein. Contract extensions must be mutually agreed upon by both Westchester County and the awarded vendor, and such agreement must be in writing, prior to the expiration date.

Fuel options shall include high octane fuel and diesel fuel. Bid prices shall be net prices for the fuel itself. Westchester County is exempt from sales tax. All fuel supplied under this contract shall be for tax exempt use only. Government imposed charges such as Federal Oil Spill Liability and NYS Spill fee charges are permitted. There will be no sales tax.

Due to the nature of fueling requirements, suppliers must have dockside fuel sources and be in close proximity to the location where County Police boats are docked and utilized on a regular basis. Therefore, bidders must be located on the Hudson River, north of the Tappan Zee Bridge but south of the Bear Mountain Bridge. Additionally, there will be two awards made from this bid. An award will be made on the Westchester side of the Hudson and on the Rockland/Orange side of the Hudson.

The final decision of whether or not a location is acceptable to the County will be made solely by the Westchester County Police Marine Patrol Supervisor.

Westchester County Police patrol boats will arrive at the fueling location on an as-needed basis during business hours of fueling site.

Westchester County purchased approximately 15,000 gallons total of fuel (which is High Octane Fuel and Diesel Fuel) during 2015. Usage may increase or decrease depending upon the needs of the County Police Marine unit. Westchester County makes no guarantee of quantity of fuel to be purchased, if any, and may cancel the contract at any time by notifying the vendor in writing with thirty (30) days notice.

The resulting contract from the award of this bid may be extended to other New York State counties and also to municipalities/political subdivisions within Westchester County. Such extension shall be upon approval or consent by awarded vendor. In such situations, the interested county or municipality, may contact awarded vendor to request to utilize the contract. If awarded vendor agrees, all transactions resulting from the agreement will be based on the contract award. Invoicing and all other issues will be between the awarded vendor and the county or municipality utilizing the contract agreement.

Bidders are asked to quote a discount in cents (US currency) from the daily posted retail price of fuel at their facilities. Bidders may also quote zero discounts, indicating the bid price as their regular daily posted pricing for retail sales of fuel with no sales tax.
