## **10. COUNTY LOGOS, EMBLEMS, PATCHES, NAME PLATES, EMBROIDERY, and SILK SCREENING**

- 10.1 The County logo applied shall meet the County's standards for size, color and content to be utilized by the Rockland County Sheriff's and Correctional/Jail. The successful bidder shall contact each department in writing for specific examples, specifications, design and styles of departmental logos prior to agreement and implementation.
- 10.2 Proposal shall include the cost of sewing on all emblems, patches, stripes, flags or chevrons. The County shall supply all emblems, patches, and flags, currently utilized by the County. The vendor shall maintain an adequate supply of all emblems, patches, and flags, on hand for future orders and all orders fulfilled shall be verified by the department as to which emblem, patches, or flags are to be sewn on and in what location on the garment. Regarding the placement, the same shall be said for any embroidered or silk-screened items embroidered or silk screened with various County emblems, patches, flags, denoted in the proposal pages of this bid. Badges, names, departments, titles etc. shall be embroidered utilizing the color thread denote on the bid specifications and examples will be provided.
- 10.3 Cost of all embroidery or silk screening per item shall be itemized separately on lines 125-133 of the proposal pages
- 10.4 For silk screening, the County will supply camera-ready artwork, compact disk (CD) or portable document format (PDF). The County shall have final approval on any camera-ready artwork. Requests for embroidery or silk screening shall be on a as needed basis.

## **11. ELECTRONIC CATALOG /E PROCUREMENT**

- 11.1. The County of Rockland requires the Offeror to have the ability to receive and acknowledge Purchase Orders from the County electronically, using facsimile, email or electronic purchase order via EDX Punch Out from Peoplesoft eProcurement version 9.2.
- 11.2. The County also prefers the Offeror to have the ability to provide a web based electronic catalog that is solely dedicated to the County. The electronic catalog shall have the following capabilities:
  - 11.2.1 Have a secure log on for Rockland County law enforcement personnel
  - 11.2.2 Website is to be exclusive to the Rockland County Sheriff's office
  - 11.2.3 Website is to be operational for the entire life of the contract.

- 11.2.4 Ability to add, change or delete individual officer's profiles for ease of ordering that to include, Officers name, size measurements and ability to update store measurements.
