SPECIFICATIONS

1. SCOPE

- 1.1. The scope of this bid is to provide scheduled preventive maintenance and emergency service on automatic transfer switches for the County of Rockland.
- 1.2. The Rockland County Sewer District #1 has begun Phase I of a project to replace the generator set, enclosure and fuel tanks at various pump stations. Attached is the projected schedule for Phase I. It is anticipated the replacement work to begin early spring of 2019 with a completion date of December of 2019.
 - 1.2.1. Bids have been received for Phase II of this project and are currently under evaluation. No schedule has been set.

2. GENERAL REQUIREMENTS

- 2.1. All maintenance and repair work shall be performed as per the manufacturer's recommendations. Preventive Maintenance and Inspection shall be performed, as specified, annually on each of the units listed on the proposal pages.
- 2.2. Visiting the Site – All bidders are encouraged to visit the job site to verify all conditions. Bidders can schedule a site visit by contacting Mr. Josue Thomas at the Rockland County Sewer District # 1, Route 340, Orangeburg, NY 10962 at (845) 365-6111. Bidder must perform as specified whether or not he visits the site.
- 2.3. When the bidder is informed that emergency repair service is required, the bidder must take whatever steps is necessary to expedite work including overtime work, evenings, weekends, and holidays. All calls for service shall result in a technician being on the job site within three hours of call.
- 2.4. All scheduled maintenance and repairs will be performed Monday through Friday from 7:00 AM to 3:00 PM. Off hours and weekend work is permitted upon written approval by an authorized RCSD#1 representative and often required to complete unplanned repairs
- 2.5. The bidder will notify the County of Rockland of any problems requiring additional work and will need the district's approval before proceeding.
- 2.6. A trained service representative will visit a site, as requested by the County of Rockland, as many times as needed in a year on mutually agreed dates and times to perform preventive maintenance work. All work will be performed in a safe and professional manner and the work area will be left in a neat and clean condition.
- 2.7. Contractor shall have a staffed office (answering machine or voice mail not acceptable) to take service calls 24 hours/day, 365 days/year.
- 2.8. The County of Rockland may inspect the facilities of the apparent low bidder prior to award to determine their capacity to perform this work. The successful bidder must maintain a satisfactory inventory of repair and replacement parts for the units specified at their warehouse and in their service vehicles. Bidder will show evidence of inventory upon request.

2.9. If at any time during the life of the contract the Contractor, in the opinion of the County of Rockland, fails to take all reasonable steps to expedite the work, the County of Rockland may unilaterally nullify the contract.

3. SERVICE PERSONNEL

3.1. Each bidder shall also submit a detailed list of labor costs with his bid. This list shall include each type of category of employee or laborer who will or might be used in any possible repair of the switches and the hourly rate at which the County of Rockland will be charged for said employees or laborers. These rates, as well as estimated material costs, shall be part of the bidder's proposal and shall be a factor considered in evaluating which bidder is the lowest responsible bidder.

3.2. Bidder must employ qualified technicians, and must submit with bid a list of current employees, who would be servicing equipment. The following information should be on the list: Name of employee, level of qualifications. All service technicians must have a minimum of three years paid documented experience in the repair and troubleshooting of equipment similar to units specified. Bidder shall employ sufficient qualified staff to perform the work specified.

3.2.1. Bidder shall have at least three years experience performing the work specified. Bidder shall complete and submit the Certification of Experience Form with their proposal.

3.3. Contractor and their service personnel shall possess all State and County of Rockland licenses required to perform the desired work. Proof of these licenses must be submitted immediately upon demand by the authorized Rockland County representative.

4. PREVENTATIVE MAINTENANCE PROCEDURE

Pricing for this work shall include all labor and material.

4.1. Preventive maintenance work shall be performed as follows:

4.2. Check equipment service records for previous problems

4.3. Interior wiring and components

4.3.1. Perform visual inspection of all wiring and connections for signs of tracking, overheating, and insulation deterioration

4.3.2. Check and tighten, where necessary, all control circuit wiring terminals, and all power connections

4.3.3. Check manual switches for free movement and contact continuity

4.3.4. Check all time delay settings and adjust to customer's specifications

4.3.5. Check, clean, and adjust where necessary, relay finger contacts

4.3.6. Check condition of main and arcing contacts and auxiliary contacts

4.3.7. Check all common ground wires, measure and record resistance to ground readings

- 6.1. The Contractor shall only perform repair work which is required. Repairs shall be performed only with the authorization of the Rockland County designated representative. Should any repair work be performed without the authorization payment will not be made. All services and repairs must meet with the approval of the authorized designated representative of the County of Rockland.

7. EQUIPMENT

- 7.1. The Contractor is responsible for providing all tools and equipment necessary to efficiently perform all work in a professional and workmanlike manner. The certificate of equipment is included in this package and must be completed.

8. TRAVEL TIME

- 8.1. All labor shall be billed from the time bidder's employee arrives at, to the time he departs from the Rockland County job site. The County of Rockland will not accept nor authorize payment for travel time or expenses of service personnel to any of the County of Rockland's facility locations. The only billable time will be for service work performed.

9. WARRANTY

10. TIME SHEETS

- 10.1. The Contractor shall submit a time sheet for each day worked on preventive maintenance. Time sheets shall only indicate equipment serviced. Details of servicing can be found on the preventive maintenance record sheets.
- 10.2. The Contractor shall also provide a time sheet for repair work.

11. BILLING

- 11.1. Detailed description of all completed work indicating labor and parts provided and work performed must be submitted for signature at the time the work is performed, and must accompany all invoices.
- 11.2. The County of Rockland must receive detailed billings within fifteen days after completion of each repair.

12. PAYMENT AND INVOICES

- 12.1. All work shall be invoiced and paid as bid on bid submission forms.
- 12.2. Detailed description of all completed preventive maintenance and/or repair work must accompany all invoices.
- 12.3. Detail billings must be received by the County of Rockland within fifteen days after completion of each job.
- 12.4. Any additional labor or material charges as authorized by the County of Rockland will be paid according to the following requirements:
- 12.4.1. Labor Charges - The invoice must list specifically the type of employee or laborer utilized and the number of man-hours worked. The Contractor's labor charges must correspond to the rates, which he will supply with the bid. The bidder agrees and hereby certifies that all labor charges contained in the bid's invoices and vouchers shall be only those that were required and necessary to complete the required work.
- 12.4.2. Material Costs - to be billed at Contractor's cost plus mark up as awarded on the proposal pages. Invoices for items over \$100 must be submitted with bills.
- 12.4.3. Additional Items - If the Contractor expects to incur any additional costs not specified in the above paragraphs, he must submit a list of those items and corresponding charges or schedule with his bid. There will be no additional charge for delivery or mileage. No other costs except those placed in the bid proposal at the time the bid is submitted shall be evaluated, considered or deemed acceptable charges by the County of Rockland. Nothing herein shall be considered to limit the authority of the County of Rockland to prosecute any bidder or Contractor who violates the laws of the State of New York.

13. PRICE ADJUSTMENT

- 13.1. The term of this contract shall be for a period for one year from its effective date, with the option for four (4) additional one-year periods. Prices are to remain firm for the first year of the contract. In the second (2) through fifth (5) year of the contract, the contractor may receive a price adjustment annually.
- 13.2. Any price adjustment will be limited to the percent increase in the CPI Index-All Urban Consumers for the preceding twelve (12) months. Consumer Price Index (CPI) is published by the U.S. Department of labor.
- 13.3. The decision to extend or not to extend the contract rests solely with the County of Rockland. It will be based on offerors ability to manage the account on product quality, accessibility, responsiveness, record keeping, delivery times, professionalism, creativity, and flexibility.

14. USE OF PREMISES

- 14.1. On or about the premises and adjacent areas, the Contractor shall ensure that all apparatus, storage of materials, and activities of workmen be confined to the limits indicated by law, ordinances, permits and the direction of the authorized County of Rockland representative, and shall not encumber or permit the premises or adjacent areas to be encumbered with such materials or apparatus.
- 14.2. The work site shall be kept in an orderly and safe fashion so as not to interfere with the progress of the work or the work of any other Contractor.
- 14.3. The Contractor shall be responsible for repairing and replacing anything damaged by his operations, within thirty (30) days after notification by the authorized County of Rockland representative that damage has occurred.
- 14.4. It will be the responsibility of the Contractor to report, to the authorized County of Rockland representative, any damages found prior to any work at this site.

15. CLEANING UP

- 15.1. The Contractor shall at all times keep the premises and adjacent areas free from accumulations of waste material or rubbish. At the completion of the work, he/she shall remove, from and about the premises, including adjacent areas, all rubbish, tools and surplus materials used for work and shall have the area "Broom Clean" and ready for use. In case of a dispute, County of Rockland may remove rubbish and clean up, then may charge the Contractor either by deduction of amounts unpaid to the Contractor, or by other means as determined to be fair and equitable by the authorized County of Rockland representative.

16. AWARD

- 16.1. Award will be made to the lowest responsible bidder meeting the stated requirements based on the total bid for the preventive maintenance and estimated repair and service work including materials. All quantities shown for repair, service, and materials are estimates. The successful bidder will be required to furnish quantities that may be more or less than the listed estimated quantities.
