1.1. 3. PRICE LISTS

3.1. Suppliers shall include in their bid the current list price catalog for the manufacturer that they are bidding. Suppliers shall also note in their bid submittal the identification number and date of the manufacturer's current price list. Updated price lists are to be submitted as they are published.

4. EXCLUSIONS

6. QUANTITIES

6.1. All window treatments will be ordered on as needed basis. There are no minimum quantity requirements. The quantities listed are based on past purchases and will be used for evaluation purposes only.

7.1. The County of Rockland reserves the right to negotiate lower pricing, or to advertise of bids, on any unanticipated excessive purchase.

8. WARRANTY

8.1. The supplier guarantees that the material used is standard new material. All materials shall be guaranteed for a period of one year against defective parts and workmanship. If defects occur during this time, they shall be replaced or corrected by the supplier without cost to the County of Rockland. All materials shall be covered by a one year warranty.

9. MATERIALS

9.1. All materials used must be fire resistant and lead proof on items where applicable. Vendor to supply flammability testing certificate on brands being offered.

10. BRANDS

10.1. Indicated brand is requested to match existing window treatments in other county buildings. Vendor may indicate other brands, where equivalent.

11. SAMPLES

11.1. Vendor to submit samples of manufacturers brands being offered and color chart of available colors if requested by Facilities Management.

12. LABOR LAWS

12.1. All installations performed as a result of this solicitation are subject to New York State Prevailing Wage Law. While the use of Union labor is not required, non-union employees must be paid in accordance with the Prevailing Wage Rate Schedule included in this solicitation.

13. INSTALLATION TIME

13.1. In an effort to conserve taxpayer dollars it is the intent of the County of Rockland to have shades installed during normal working hours. Monday - Friday from 8AM - 5PM.

14. **DELIVERY TIME**

14.1. Suppliers shall state, in their bid, on the proposal pages, the delivery time in weeks from receipt of approved floor plan if the delivery time frame differs from the three to four-week time frame as stated on page one of the bid.

15. RESTRICTIONS

15.1. Bids containing restrictions will not be acceptable unless the Rockland County Purchasing Department deems the restrictions conform to the County of Rockland requirements.
