- 1.1. The County of Rockland Sheriff Police Academy requires the audio video equipment as specified or approved equal. Modifications of or additions to basic standard model(s) indicated or less size or capability to meet these requirements will not be acceptable. Equipment furnished shall meet or exceed specifications. This bid is for the purchase of equipment only as the items shall be installed by an authorized County representative.
- 1.2. This bid is comprised of two sections. Section 1 will be to furnish, deliver new equipment as listed along with a Percent Discount line for various mounts, etc. to be determined prior to ordering. Section 2 is a Percent Discount from Manufacturer National Price Lists line for the various brands offered for additional items that may arise after award. If not offering a discount, zero percent shall be entered.

2. REQUIREMENTS

- 2.1. All line items in each section shall be bid on to be considered for award.
- 2.2. Bidder must be an Authorized Dealer/Reseller for the brand(s) they are bidding and provide documentation with bid.
- 2.3. Equipment shall be New Unused and in its original packaging.
- 2.4. All items must be as specified or approved equal.
- 2.5. Bidders shall respond to both Sections of this bid or both; all lines within a section shall be completed and responded to.
- 2.6. Bids received without all lines within a section completed shall be determined to be non-responsive and shall be rejected.

- 4.1. The use of a brand name is for the purpose of describing the standard of quality, performance, and characteristics desired and are not intended to limit or restrict competition.

5. APPROVED EQUALS

- 5.1. If the bidder is bidding an approved equal, he must first provide references showing locations the County of Rockland can visit of the exact make and model intended to be supplied. If bidding an alternate or approved equal, two copies of brochures, specifications, and any other pertinent information must be sent with bid.
- 5.2. In the event that an alternate is bid, the County of Rockland reserves the right to request a demonstration of the specific model bid. Failure to furnish the demonstration will render the bid, for that item, as non-responsive.
- 5.3. Any units not conforming to these specifications may be rejected, and it will be the responsibility of the manufacturer to conform to the requirements unless exceptions have been specifically cited by the bidder and acceptance made on the basis of the exceptions. Each bidder is required to respond to every requirement in this specification with the appropriate explanation of equipment when specified and supply all requested information with bids.
- 5.4. The County of Rockland will make the final determination on whether the equipment is considered an approved equal.

6. CONTRACT PRICE ADJUSTMENTS UPON RENEWAL

- 6.1. The bid rates shall remain firm through the first contract period with no adjustments allowed. If the County exercises any of the option years of the award, Contractor may submit a request for adjustment on the yearly anniversary date of the contract. Any request for price adjustment(s) shall be submitted thirty (30) days in advance in writing to the Director of Purchasing. Any and all price adjustments will be limited to the percentage increase in the CPI Index – All Urban Consumers for the preceding 12 months. The County reserves the right to reject any request for price increase deemed excessive.
- 6.2. CPI-Index - Consumer Price Index for All Urban Consumers as published by the Bureau of Labor Statistics of the United States Department of Labor or a successor or substitute index, appropriately adjusted.
- 6.3. Vendors shall submit a letter to the Director of Purchasing, during the term of this bid, addressing any unscheduled price increases from the manufacturers. This letter must include on the manufacturer's letterhead all information to support any unscheduled increase. Any increase authorized is at the sole discretion of the Director of Purchasing and shall be in writing.

QUESTION #1 - Item#10 JBL model "CBT100/ CBT1000E" does not exist. I believe you are looking for two separate part numbers. The JBL CBT1000 speaker and separate item JBL CBT1000E (an extension for the speaker). Please confirm this line should actually be two separate lines with qty 2 of each (qty2 CBT1000 and qty2 CBT1000E).

ANSWER #1 – One bid line but to include both items – you can add the price for both pieces together into one total x 2 complete units.

QUESTION #2 - Item#17 Crestron FT-TS500-B does not exist. Did you mean Crestron FT-TS600-B?

ANSWER #2 – Yes – Typo – P/N Should be TS600-B.

QUESTION #3 - Item#23 ELMO PX-10 (Product# 1366) has been discontinued and replaced by ELMO PX-10E (Product# 1417). Will you accept this as Approved Equal?

ANSWER #3 – Yes acceptable.

QUESTION #4 - Item#25 SONY VPLL-Z4011 lens has been discontinued and replaced by SONY VPLLZ-4111. Will you accept this as Approved Equal?

ANSWER #4 – Yes acceptable

QUESTION #5 – Question relates to the first set of Shure components that are specified within the first component group from Item #1 to Item #6, asking if the County currently owns any of the Shure MXWANI8, 8 Channel Audio Network Interfaces that are currently installed with this location, noting the MXWANI8 Network Interface are required to provide the Microflex wireless system's analog outputs to the specified Crestron DSP-1281 processor, noting the bid package only specifies the (2) MXWAPT8 Access Point Transceivers, which is basically an antenna that connects to the MXWANI8 Network Interface.

ANSWER #5 - The county does not presently own any equipment related to this project location.

QUESTION #6 - The next component question involves Item #6, the Shure MX415/C gooseneck microphone, noting that this microphone requires the use of a preamplifier for use in a wired application or the Wireless Base Transmitter if required to be used in a wireless application, and based on this project's budget the gooseneck microphone and base transmitters could replace the specified MXW2/SM58 handheld transmitters and DS-7E stands. INCLUDES FOLLOW-UP: I'm writing as a follow up to my previous submittal and noting my one oversight which involved the specified Shure MX415/C gooseneck microphone, noting once I started to apply this bid's components into a quotation I verified the MX415/C gooseneck microphone does contain the MX400DP surface mount preamplifier.

QUESTION #7 - My third question relates to the, along with a verification of Item #35, asking if the installation labor for the specified components, along with programming and operational training are to be considered as the Rigging Hardware, or if the County is going to provide all specified component installation, programming and training, noting that I do not find any line items within this bid package that specifies onsite installation, system programming or staff members operational training.
