SPECIFICATIONS

1. **SCOPE**

- 1.1. Contractor shall provide all labor, equipment, materials and supervision as required to perform water analysis and chemical treatment for the various mechanical systems as specified herein.
- 1.2. All systems shall be properly maintained to prevent fouling, scaling, corrosion, solids buildup and any other physical or chemical abnormalities, which would be detrimental to the proper operation and life expectancy of the systems specified herein. All systems shall be maintained in accordance with accepted industry practices and methods, and original equipment manufacturer's recommendations. Contractor shall maintain proper inventory levels of all Treatment Chemicals.
- 1.3. Contractor shall apply, maintain and record usage of pesticides for all heating and cooling systems. Contractor shall document and record all pesticide applications in annual report as required by New York State DEC and LISEPA. Report shall be provided to the Director, Facilities Management.
- 1.4. Contractor shall provide all labor, equipment, materials and supervision as required to perform seasonal startup, inspection, disinfection, and testing for Legionella as required by New York State Department of Health Regulations on all cooling towers for the various mechanical systems as specified herein. Contractor shall develop a written maintenance plan in compliance with current NYS regulations. Plan shall be provided to Director of Facilities Management.

2. SYSTEMS AND EQUIPMENT COVERED

2.1. The systems and equipment covered are listed in Section 9, Part A, and Section 10, Part B of these specifications.

3. PRE-INSPECTION BY BIDDER

3.1. All prospective bidders are encouraged to visit the job site to familiarize themselves with all equipment and systems before submitting their bid. Bidders are to contact Mr. Patrick Horan, Assistant Director, Facilities Management for the Pomona and New City sites (845) 364-3846, to schedule an appointment. Bidders must perform as specified whether or not he visits the site.

4. CONTRACT PERIOD

- 4.1. The contract period shall be eighteen months from the date of award with the option to renew for three additional one-year periods.
- 4.2. The County of Rockland anticipates the sale of the Sain Building, 18 New Hempstead Rd, New City, NY 10956 during the term of this contract. When sold, services for this location will be terminated.

5. SERVICES TO BE PROVIDED

5.1. The successful bidder shall provide all necessary supplies and services, including but not limited to chemicals, analytical supplies and equipment, test kits, analytical services and other services or materials necessary to comply with the specifications. Owner will provide the labor for the addition of chemicals and daily testing of the systems as required.

- 5.2. All chemicals and equipment, necessary for treatment shall be provided by the vendor and their cost shall be included in the bid price. This shall include analytical test kits related equipment including pumps, timers and piping.
- 5.3. All work shall include a monthly visit, Monday through Friday 9:00 AM to 3:00 PM not exceeding four weeks, by a service technician possessing the necessary skills required to meet the specifications. During the visit, the service technician shall perform analysis tests for all systems and review Owner's test results for the previous month. During the air conditioning season, starting April 15 through October 15, successful bidder shall make scheduled bi-weekly visits to all sites to perform analysis of all cooling tower and circulating system water. Missed or late site visits shall be back charged.
- 5.4. Immediately after award is made, Contractor shall thoroughly review all systems specified and proposed treatment methods with the contact personnel listed, or their designee. Within one week after award, vendor shall provide at each location, typed instructions including tests to be performed, guidelines and testing procedures, weekly forms with hi/low limits, method and frequency for taking analysis tests, method and frequency for adding chemicals, target results, and any other information necessary to meet the specifications including water analysis training to County of Rockland personnel.
- 5.5. During the cooling season, Legionella inspection, disinfection, sampling and testing shall be done monthly. Re-disinfection, re-inspection and retesting shall be done on an as needed basis.

6. QUALIFICATIONS OF BIDDERS

- 6.1. Successful bidder shall have a minimum of five years full-time documentable experience in the chemical treatment, analysis and related servicing of systems as specified herein.
- 6.2. All bidders shall submit with their bid a list of five accounts similar in size and scope to the work specified herein, which they have serviced within the last year. Bidder shall include contact person, telephone number and a brief description of services provided.
- 6.3. Successful bidder shall have a minimum of three service technicians on their staff, who are experienced in performing the Scope of Work specified herein. Each technician must have a minimum of three years full-time documentable experience in such work. Bidder shall submit with their bid a brief description of the required experience.
- 6.4. Technicians shall be certified in cooling tower category 7G by the NYS Department of Environmental Conservation. Bidder shall provide copy of certification. Failure to supply may deem bid non-responsive.
- 6.5. All bidders shall prove to the Owner satisfactorily that they have the necessary staff and facilities necessary to properly perform the services specified. If requested, bidder shall allow the Owner to visit and inspect their main business location to determine its ability to meet the requirements of these specifications.
- 6.6. Successful bidder shall <u>employ on staff</u> a chemical engineer with a minimum four years of experience in performing the work as specified herein. This staff engineer shall have a minimum of one year's consecutive full-time documentable experience in such work. 7. **REPORTS**

7.1. After each of the required scheduled service visits, Contractor shall provide both a typed report and an electronic copy (MS Office) to the Director, Facilities Management within 48 hours indicating all analysis and treatment results and recommendations. All covered systems shall be included in this report.

8. TREATMENT CHEMICALS

- 8.1. Chemicals provided shall conform to all rules and regulations of OSHA and the New York State "Right to Know" law. Owner reserves the right to reject delivery of any chemicals that are not properly packaged, labeled and provided with all information in compliance with these regulations. Any losses of chemicals incurred because of delivery rejection by the Owner shall be at the Contractor's expense.
- 8.2. All chemicals are to be furnished in original manufacturer's containers and properly labeled to meet all OSHA regulations. Re-packaged and expired chemicals will not be accepted.
- 8.3. Owner shall be provided with manufacturer's Material Safety Data Sheets for all chemicals, prior to, or at time of delivery.
- 8.4. All chemicals shall be of a form and quality necessary to achieve their intended purposes.
- 8.5. All chemicals shall be transported in accordance with applicable governing law, including New York State Department of Transportation and New York State Department of Environmental Conservation.  - 9.2.4. The high-pressure boilers operate at 45 PSIG from 6:00 a.m. to 7:00 p.m., seven days a week.
- 9.3. <u>LOW PRESSURE BOILERS</u> There are three identical low-pressure boilers with name plate data as follows:
 - 9.3.1. 700 H.P.
 - 9.3.2. 29,291,000 BTU/hr. input

- 9.3.3. Operating Pressure 10 PSIG rated 15 PSIG
- 9.3.4. These boilers are used in the winter for heating and hot water tank all year.
- 9.3.5. During the heating season, one of these boilers serves most of the Health Complex. This includes Buildings A, C, D, E, F, G, H, J, K, L, P and R. During this time, the boiler operates at between 50 and 100% of capacity: averaging about 75%.
- 9.3.6. Low pressure condensate is 100% returned to a large condensate return tank located in the Boiler Room. This tank is not a de-aerating feed water heater, but is lagged and heated with a steam sparger. It has an automatic feed of demineralized water when the water level drops too low.

9.4. <u>CIRCULATING SYSTEM WATER</u>

- 9.4.1. All heating is done, indirectly through heat exchangers with a two pipe circulating water system. The water is heated in the winter and pumped throughout the Complex buildings (as detailed above). The underground piping is Johns Manville high temperature, high pressure epoxy lined transite pipe.
- 9.4.2. Once in the buildings, the water circulates through either fan coils or Unit Heaters.
- 9.4.3. The capacity of this system is estimated at approximately 28,000 gallons.

9.5. CHEMICAL FEED EQUIPMENT

- 9.5.1. <u>HIGH PRESSURE BOILERS</u> One pump pumps directly into the de-aerator.
- 9.5.2. <u>LOW PRESSURE BOILERS</u> Chemical addition for this system is done by means of bypass feeders in conjunction with feed water pumps which are fed by chemical feed pumps.
- 9.5.3. <u>CIRCULATING SYSTEM WATER</u> Chemical addition to this system is done with a bypass feeder.

10. EQUIPMENT AND SYSTEMS DESCRIPTION – PART B

10.2.3. TREATMENT DESIRED

Bidders shall be permitted, at their expense, to take and analyze water samples for the purpose of developing their bids. Successful bidder shall provide the Owner with a complete raw water and systems analysis at the Dr. Robert L. Yeager Health Center, Rockland County Government Center at the commencement of their contract.

12. TOXICITY

12.1. No chemicals used in the boilers and condensate return systems shall be toxic or harmful in any way, in case traces of them become entrained in the steam. Chemicals used for the treatment of condensate return system shall be safe for use with food preparation equipment.

13. PRICING

All chemicals, parts and materials used for services and repair not covered under the contract specifications shall be listed on the invoice by manufacturers name and model number and shall be billed at a percentage mark-up. **Mark-up shall not exceed 10%.** Bidder shall enter a % mark-up between 0%-10% on the proposal pages. There shall be no mark-up on freight.
- 13.3.2. Documentation of material costs (invoices, etc.) of items greater than \$100 must be provided with Contractor's invoices.

14. CONTRACT PRICE ADJUSTMENTS UPON RENEWAL

- 14.1. The bid rates shall remain firm through the first contract period with no wage adjustments allowed. If the County exercises any of the option years of the award, Contractors may submit a request for adjustment on the yearly anniversary date of the contract.
