1. SCOPE:

- 1.1 To provide embroidery of uniforms and apparel including badges, names, ranks and miscellaneous embroidery on the chest of Sheriff's, Security, and various Rockland County Department uniforms. The badges and all letters including the letters "RC" and "SO" for shirt collars and five (5) point stars are to be in gold, silver, or blue denoted in pictures attached. Names and ranks will also be in gold, silver or blue with maximum number of letters set at twenty-four (24).
- 1.2 Badges may also contain rank or department as per attached specifications. Security badge should consist of no less than 35,000 stitches.
- 1.3 (see attached sample of badges, names, and ranks in Gold, Silver and Blue)
- 1.4 Provide embroidery on a quote basis for various non-contracted items for use by various County Departments

2. SPECIAL REQUIREMENTS

- 2.1 Shirts are to be delivered by Rockland County Sheriff's Department to firm awarded the quote and anticipated costs of delivering the shirts based on round trip mileage shall be used in the analysis and award decision. Shirts will be picked up at awarded vendors location after embroidery.
- 2.2 Security Badges sizes are to measure 3 ³/₄ H x 3 ¹/₂" W and are to be embroidered in gold or silver based on attachment specifications (Picture Attached).
- 2.3 Letters 'RC" and "SO" are to measure .95"H X .61" W, letters "RC" to be embroidered on right of collar and "SO" to be embroidered on left side of collar. Both letters are to be embroidered in either gold or silver to and match thread color of badges.
- 2.4 To clarify which side of collars letters are to be applied, right and left side of collar is determined as if you were wearing shirt "RC" on right collar and "SO" on left collar.
- 2.5 Seven-point Sheriff's badge to be bid as shown in sample with only variations to be rank or department personalized in position denoted on badge.
- 2.6 Five (5) point stars to be embroidered on shirt collars in gold or silver (see attached pictures)
- 2.7 Embroidery of gold or silver bars o shirt collars measuring ¹/₄"H x ³/₄" W maximum two bars per collar (see sample picture)
- 2.8 Police and Public safety academy logo

- 2.11 Any artwork developed for embroidered badges from metal version will become the property of the County of Rockland.

3 Award

3.1 Embroidery will be awarded based on "Best Value" and firms that qualify as a Rockland based small business enterprise will be given preference. Also, travel time and distance to drop off uniforms from New City, Pomona and Orangeburg will be included in award analysis.




- 1. The County of Rockland shall make all contract award information available to non profit agencies through our website: **www.rcpurchasing.com**
