### STATEMENT OF OBJECTIVES

The County of Rockland has issued this Request for Proposal to establish a fixed price contract to facilitate Health and Safety training on a regular/ periodic basis to County Employees on an as needed basis.

As the needs arise for Health and Safety training, an Authorized County Representative shall solicit project specific; technical, man-hour and project cost proposal based on the rates provided in the initial proposal response and project schedule for the specialty required. A contract will be issued on the basis of the authorized County Representative's evaluation of the technical and man-hour proposal.

In general there are monthly meetings and classes are held as needed. There is no set schedule. The Chair of the Health and Safety Committee determine when a class is needed. The average class may include 15- 20 students per class.

Typical project assignments may include, but is not limited to, the following:

1. The Consultant will develop, provide / facilitate Health and Safety training on a regular/ periodic basis to County Employees, as mandated by OSHA, PESH and other State, Federal Laws and as identified by the County. The development of such training shall be based upon guidance from the Office of the County Executive, Department of Personnel, or other authorized County Representative and the Office of the County Attorney. The Consultant shall, if requested, develop an appropriate survey instrument and complete an evaluation of the effectiveness of the training. These training programs will also be developed and implemented on an as-needed basis and may include but is not limited to:
  - Right-to-Know / Hazard Communication
  - Training sessions to review DOSH standards and brief Management on new and/or developing standards.
  - Hearing Conservation
  - Lockout / Tagout
  - Respiratory Protection
  - Confined Space Entry
  - Forklift / Powered Vehicle
  - Emergency Response / Evacuation / Life Safety
  - Safe Operation of Cranes / Hoists
  - Traffic Safety / Barricading
  - Hazwoper
  - Trenching and Excavating
  - Bloodborne Pathogens for Healthcare Professionals
  - Bloodborne Pathogens for Non-Healthcare Professionals
  - At Risk Behavior
  - Electrical Safety
  - Personal Protective Equipment
  - Gas detector Training
  - Asbestos Management / Abatement
  - Defensive Driving & Professional Truck Drivers DDC
