1. DETAIL SCOPE OF WORK

This section describes the services that are required to be provided by the selected Proposer. Proposers must demonstrate proficiency in testing for Alcohol and Drugs, providing reports and expert testimony.

- 1.1. This RFP is for the purpose of Alcohol/Drug Testing Services (urine toxicology and oral fluid) for the County of Rockland departments. All work must be completed in accordance with the listed specifications.

2. REQUIREMENTS

- 2.1. Proposer must provide alcohol and drug testing services as required by the County of Rockland requesting departments.
 - 2.1.1. All urine sample containers, oral fluid collection devices and other sample materials are to be provided free of charge.
 - 2.1.2. Proposer must supply Chain-of-Custody Forms.
 - 2.1.3. Samples are to be picked up at no additional cost.
- 2.2. Proposer must perform work in conformance with all Federal, New York State, Local Laws and Regulations.
 - 2.2.1. Testing must be performed in compliance with industry standards for drug and alcohol testing.
- 2.3. The Proposer must provide Video Collection oral fluid drug and alcohol testing kits as required by the County of Rockland.
 - 2.3.1. Collection devices and other sample gathering supplies are to be shipped directly to the patient/client's home address, as provided by an authorized Rockland County representative.
 - 2.3.1.1. Collections kits are to be delivered free of charge with a return shipping label.
 - 2.3.2. Video Surveillance will be live video viewed by the laboratory or by the County of Rockland using department.
- 2.4. The using Departments may require instant drug testing kits on an as needed basis.

3. PICKUP AND REPORTING

- 3.1. Urine and Oral Fluid samples will be picked up, Monday, Wednesday and Friday between the hours of 9:00 AM to 2 PM at the following locations:

- 3.1.5. All samples will be picked up free of charge.
- 3.1.6. Reports for all tests performed must be available within three (3) business days after pickup of specimens with exception to those test that specifically require longer processing time.
- 3.1.7. Verbal reports may be given to authorized personnel by telephone within two (2) business days after pickup of specimens.
 - 3.1.7.1. Using Departments will provide a list of Authorized Personnel upon award of this contract.
- 3.1.8. All negative results of specimens must be transmitted within twenty-four (24) hours. All positive results must be transmitted within forty-eight (48) hours or sooner.
- 3.2. Specimens and test request forms will indicate only the ID number of the patient/client, collection date and the test(s) required. Patient/Client Name may be included when the using Department request names to be listed.
- 3.3. All completed laboratory reports must be reviewed and initialed by a licensed laboratory supervisor.

4. IN-SERVICE

- 4.1. Proposer must provide a dedicated representative(s) to the County of Rockland Departments using these services to provide information and resolve issues during the term of this contract.
- 4.2. Proposer will provide in-service training to any County of Rockland Departments that may request this service.

4.2.1. Provide details regarding training programs, including how to order tests including test panels and testing procedures and results.

5. TESTING METHODS

5.1. Urine Toxicology Drug and Alcohol Screening shall be performed by Immunoassay Methods (e.g. EMIT, EIA, ELISA or a testing method approved by the County of Rockland authorized representative).

5.1.1. All positive Urine Toxicology Drug and Alcohol Screening results must be confirmed by one of the following, GC/MS, LC/MS/MS or a testing method approved by the County of Rockland authorized representative.

5.1.2. All Urine Ethanol Alcohol results must be confirmed by GC-FID or a testing method approved by the County of Rockland authorized representative.

5.1.3. Oral Fluid Drug and Alcohol Screening shall be performed Immunoassay Methods (e.g. EMIT, EIA, ELISA or a testing method approved by the County of Rockland authorized representative).

5.1.4. All positive Oral Fluid Drug and Alcohol Screening results shall be confirmed by one of the following, GC/MS, LC/MS/MS or a testing method approved by the County of Rockland authorized representative.

5.1.5. All Oral Fluid Ethanol Alcohol results shall be confirmed by GC-FID or a testing method approved by the County of Rockland authorized representative.

6. QUALIFICATIONS

6.1. The laboratory must be licensed by the New York State Department of Health, accredited by The College of American Pathologists or an approved accreditation organization for clinical laboratories. A copy of this license must be included with the proposal submission.

6.2. Bidder shall submit the following with their RFP:

6.2.1. List a minimum of three references in which similar business was performed within the last three years.

6.2.2. List of reference laboratories (subcontractors) that may be utilized to perform work on this contract.

6.2.2.1. Applicable license(s) and certificate(s) from the reference laboratory must be submitted with the proposal.

6.2.2.2. The contractor must notify the County of Rockland prior to the use of any new reference laboratory that may be used for this contract, the use of the laboratory must be approved by an authorized representative of Rockland County.

6.2.3. Provide all information on any State or Federal litigation in the past two years.

6.3. Successful vendor will be subject to a three-month evaluation period (both performance and meeting all requirements of the RFP).

6.4. If required, the laboratory must provide a tour of his facility to the Authorized County of Rockland Representative.

6.4.1. The tour will be scheduled within five working days of request and will be conducted at a time of day requested by the County of Rockland.

6.5. Third Party Administrators must meet all qualifications, testing turn around times and testing capabilities of the Request for Proposal.

6.5.1. A list of laboratories used for testing must be submitted with the proposal.

6.5.2. Laboratories used must remain consistent. If a change is made to a laboratory, it must be submitted in writing with thirty (30) days' notice and approved by an authorized Rockland County Representative.

6.5.3. Third Party Administrators must have the ability to provide court testimony.

7. PRICING AND INVOICES

7.1. Proposer must submit a price list for any test not included in this bid. Proposers who don't provide a complete price list of tests may be rejected.

7.1.1. Proposer must enter a percent discount for all test that are not listed on the bid table. If no discount is being offered off price list, the proposer must enter zero (0).

7.2. Invoices must be billed at the stated price which is awarded on the contract.

7.2.1. Invoice must state the drugs that were tested, confirmations that were completed and any other services provided.

7.2.2. All pricing for panels and/or individual standalone test must include confirmation testing of any positive results.

7.2.2.1. If the using department request an additional confirmation test to be performed this can be billed separate at the percent discount rate.

7.3. Proposer must include a sample invoice.

7.4. All invoices will be paid for all authorized testing by the County of Rockland upon submission of properly executed invoices.

7.5. All invoices must list the following information:

- 7.5.1. Date of Specimen Collection
- 7.5.2. ID Number and Accession Number
- 7.5.3. Test name
- 7.5.4. Test number, if applicable
- 7.5.5. Bid Item number
- 7.5.6. Itemized fees
- 7.5.7. Department Sub-unit (if required)

7.6. All invoices must include a summary page which includes a listing of the test number, description and quantity of test(s).

7.7. Each County Department must have a separate account number and each Department will be invoiced separately.

7.7.1. Any Departments with multiple sub-divisions shall be billed individually by division.

7.7.2. Department of Probation invoices must separately state by identified Department of Probation subunits, the number of tests performed and the cost thereof, for the following originating sub units:
