5. DELIVERY

- 5.1. Time is of the essence on the delivery of all work uniform, and polo/golf shirt orders. Supplier must deliver all items on the Price Schedule, with embroidery, emblems, patches, screen printing etc. within thirty business days after receipt of order.
