#### 1. SCOPE

- 1.1. The scope of this bid is to provide unit pricing to furnish and deliver the rotating assembly specified and replacement parts listed for Hayward Gordon Pumps. These prices are to remain in effect for one year from date of award with the choice option to renew for one additional year. Items will be ordered on an as needed basis.
- 1.2. The Rockland County Sewer District #1 has an immediate need for the purchase of one (1) Rotating Assembly for Hayward Gordon Grit Pump Serial Number HG323483U-1/2/3 (see drawing and parts listing).
- 1.3. The Rockland County Sewer District #1 has the following Hayward Gordon pumps in service.

#### 4. APPROVED EQUAL OR EQUIVALENT PRODUCTS

- 4.1. Bidders Must submit an item by item listing and comparison between their products specifications and performance and the specifications and performance of the listed bid specifications. Product and service warranties must be included with bid. Failure to comply with this requirement Must deem your bid as non-responsive.
- 4.2. If bidders submit or bid for equivalent or approved equal products, they must submit manufacturer's product description and specifications.
- 4.3. Bidders must list three entities currently using the product on the certification of experience page in the bid package.
- 4.4. Bidder Must be able to demonstrate within three days after notification and guarantee in writing the interconnectability of equivalent products with existing equipment.

#### 5. INTERCONNECTABILITY

5.1. This equipment must have the ability to interconnect with the existing equipment. Bidder must guarantee interconnectability in writing when requested. In addition, vendor must provide any required data within five business days of request from the Rockland County Sewer District # 1 authorized representative.

#### 6. PRICE ADJUSTMENT

- 6.1. The County recognizes this product or service has a price component that may have a commodity with changing costs. The Contractor/Supplier may request a Price Adjustment no more frequently than once each quarter (3-month period).
- 6.2. A Price Adjustment request must be made in writing and include the reason for the request, documentation supporting the request (ie, commodity increases), the current pricing, and the requested revised pricing.
- 6.3. The County will review the Price Adjustment request. If the Price Adjustment is deemed reasonable the Price Adjustment request will be accepted by written acknowledgement. If the request is not accepted the County may entirely reject the request or may counter with revised pricing. In either case the County will provide a written explanation in support of the decision.
- 6.4. The Director of Purchasing may use available indexes (e.g. CPI or PPI) to determine if the requested Price Adjustment is reasonable. Typically, a Price Adjustment that exceeds 5% will not be approved unless very unusual and significant changes have occurred in the industry.
- 6.5. In the event industry costs decline, the County shall have the right to receive, from the Contractor, a reasonable reduction in prices/pricing that reflect such cost changes in the industry. The County will make a written request to the Contractor for a Price Adjustment in writing with supporting documentation.
