1. INTENT

- 1.1. The County of Rockland is requesting bids on law enforcement uniforms for men's and women's Anchor 210BL men's 710BL women's blouse coats and 230BL men's and women's 730BL pants with gold or silver NYS buttons and Metallic Vellum US Navy Gold lace sewn on outer seam of pants and on sleeves of coats for the Rockland County Sheriff's, Corrections, Civil and Patrol personnel.

2. SCOPE of WORK

- 2.1. Offeror is to provide all Sheriff's, Correction's, Civil and Patrol personnel, uniform coats, and pants described herein. Blouse Coats Pants shall include 1/2" Metallic Vellum Lace US Navy Gold sewn on pants and 1/2" Metallic Vellum Lace US Navy Gold sewn on blouse coat sleeves. One row on Lieutenant's coats and two rows on Captains and Chiefs Coats with 1" gap between for gold stars to be applied in between. Lace is also to be sewn on pants outer seam.
- 2.2. Not all coats and pants will be ordered with Lace on pants or sleeves.
- 2.3. Offeror and is to take all measurements and provide all needed alterations for blouse coats and pants specified in this bid, if deemed necessary by the County. The term "Offeror" herein shall mean successful Offeror.
- 2.4. Sheriff's shoulder patches will be supplied by the County and are to be adhered to Blouse coats on shoulders.

3. MINIMUM QUALIFICATIONS

- 3.1 At a minimum the Offer shall meet or exceed the following qualifications:

- 3.1.1 Have been in business a minimum of 3 years for sales, distribution, alterations and embroidery of Law Enforcement uniforms and accessories.
- 3.1.2 Have physical location able to service the County as required in the specifications. The location shall be staffed with live customer service personnel available during normal business hours and an automated answering system during non- working hours.
- 3.1.3 Ability to accurately measure and record all County law enforcement personnel and make records available to County upon request.
- 3.1.5 Offeror is to provide a designated Account Manager to work closely with County Purchasing and law enforcement in resolving any issues that may arise. All issues are to be addressed and resolved within (14) business days.

4. REQUIREMENTS

- 4.1. All affidavits must be completely filled out, notarized, signed, and returned with bid.
- 4.2. Certificate of Experience form must be completed, signed, and returned with bid.
- 4.3. Please type or print legibly in blue or black ink. If we are unable to read the information, that item will be rejected.
- 4.4. Bids must be on original bid form. No photocopies accepted.
- 4.5. Delivery time must not be greater than fifty working (50) days from receipt of purchase order. Based on current supply chain issues an additional ten (10) working days may be allowed.
- 4.6. Each order is to be individually packaged in a plastic bag, clearly marked with the officer's name and size.
- 4.7. The successful vendor (s) will make available to the County of Rockland the services of a trained technician to take individual measurements of the officers of these uniforms for the final fitting. These services may be required quarterly each year at locations to be determined by the County of Rockland.

5. DURATION AND PRICE ADJUSTMENT

- 5.1. The term of this contract shall be for a period for one year from its effective date, with the option for one (1) additional year. Prices are to remain firm for the first year of the contract. In the second (2) year of the contract, the contractor may receive a price adjustment annually.
- 5.2. Any price adjustment will be limited to the percent increase in the CPI Index-All Urban Consumers for the preceding twelve (12) months. Consumer Price Index (CPI) is published by the U.S. Department of labor.

- 5.3. The decision to extend or not to extend the contract rests solely with the County of Rockland. It will be based on offerors ability to manage the account on product quality, accessibility, responsiveness, record keeping, delivery times, professionalism, creativity, and flexibility.

6. INVOICES/PACKING SLIPS

- 6.1. Original invoices shall be submitted to: The **Commissioner of Finance, County of Rockland, 50 Sanatorium Rd. Pomona, New York 10970**. All invoices must show the Purchase Order number, item description, quantity and contract price.
- 6.2. Rockland County's purchase order number must be referenced on all packing slips. Additional information shall include Officers name, item number and description, quantity, and size of item. All packaging should be package by individual officer by name and department.

7. PRICING

- 7.1. The pricing is to include sewing of stripes on pants and blouse coats, measuring, hemming and any alterations which will be provided by vendor.

8. SAMPLES

- 8.1. If bidding alternate brand other than specified, bidder must send detailed specifications, a catalog or a sample, including brand name and product number, (marked appropriately with item number from bid proposal pages in Bidnet) with bid.
- 8.2. The use of a brand name is for the purpose of describing a standard of quality, performance, and characteristics desired and not intended to limit or restrict competition.
- 8.3. Samples may be requested for evaluation. The County of Rockland's decision if the item will be considered as an equal is final.
- 8.4. When submitted, samples must be labeled with bidder's name and item number from proposal pages. Samples must be received prior to bid opening.
- 8.5. Samples are to be sent to the Rockland County Purchasing Division at 50 Sanatorium Road, Building A, Sixth Floor Pomona, NY 10970. Attn: Rich Ryan.
- 8.6. Samples will be returned upon request. A call tag will be required for return of samples.
- 8.7. All items of clothing must contain a manufacturer's name, RN or WPL number.

- 8.9. Bidder shall send size chart for all items with bid indicating numbers or letters. If letters are used, bidder shall indicate corresponding number size.
- 8.10. Where women's sizes are requested, they shall be true women's sizes.
- 8.11. No substitutes are allowed. If an item is discontinued during the bid period, a replacement may be offered. Such a replacement must be approved prior to shipping.
- 8.12. Exchange for size. Should incorrect size be sent or should item not fit properly, exchange for correct size shall be permitted or item alternation made to satisfaction. There shall be no return or restocking charges on incorrect items made/sent. Item being returned must not be worn (except for try on) and must be returned in the condition it was received.
- 8.13. The County also prefers the Offeror to have the ability to provide a web based electronic catalog that is solely dedicated to the County.

9. AWARD

- 9.1. The County reserves the right to award the total bid to one vendor or to the "lowest responsible bidder" that has supplied and met all the bid requirements.
