### 1. SCOPE

- 1.1. The County of Rockland Department of General Services - Purchasing Division is requesting bids from interested organizations to provide Vehicle Warning Lights, Electronic Sirens, and Light Bars to satisfactorily support the County's Law Enforcement, Emergency Services, Public Works, and Fire Departments as well as other public agencies supported under this contract. This Invitation to Bid is issued on behalf of the County of Rockland and members of the Empire State Purchasing Group.
- 1.2. To establish an annual agreement for a Percent Discount Off of the Current Published Price List and/or Catalog price for vehicle warning lights, electronic sirens, and light bars purchased by various Rockland County Departments and other Local Government Agencies throughout New York State. In addition, any other government within the State of New York and United States of America may purchase through the resulting contracts at the prices provided in the contract award.

Also, the Contractor may, but is not required to, extend the prices, terms, and conditions of this contract to any state agency, political subdivision or district located in New York State or other state within the United States. Usage of this contract by any of these other entities will have to be coordinated between that entity and the Contractor. Orders placed against this contract by other entities will be contracts solely between the Contractor(s) and those entities. Rockland County will not be responsible for, nor will it have any liability or other obligation for, such contract between the Contractor(s) and any third party.

This Cooperative Bid is intended to achieve the following objectives:

- 1. Provide a comprehensive competitively solicited County Contract offering Products to Participating Public Agencies;
- 2. Establish the County Contract as a Supplier’s primary offering to Participating Public Agencies in the Hudson Valley area and State of New York;
- 3. Achieve cost savings for Suppliers and Participating Public Agencies through a single competitive solicitation process that eliminates the need for multiple bids;
- 4. Combine the volumes of Participating Public Agencies to achieve cost effective pricing;

**1.4. Therefore, respondents to this acquisition must give due consideration to the potential market when providing bid prices.**

1.5. Individual purchases that exceed \$10,000 or other large quantity purchases, that may bring additional discounts because of quantity or price, may be bid or quoted separately by any participating organization.

**2. GENERAL CONDITIONS**

2.1. The successful Bidders shall be required to ensure timely and complete deliveries of product. Repeated delayed or partial deliveries shall be interpreted as failure to meet contractual obligation and cause for cancellation of the contract.

2.2. All parts not specifically mentioned which are necessary for the unit to be complete and ready for operation or which are normally furnished as standard equipment shall be furnished by the vendor. All parts shall conform in strength, quality and workmanship to the accepted standards of the industry.

- 2.3. The unit provided shall meet or exceed all Federal and State regulations and standards in effect which are applicable to the equipment at the time of manufacture.
- 2.4. The vendor must have experience in warranty repair work as well as be a factory authorized dealer. Vendor shall provide documentation that they are a factory authorized dealer with their Bid submission.

**3. SPECIAL TERMS AND CONDITIONS**

- 3.1. The successful Bidder shall be responsible for making the distribution of a new Current Published Price List and/or Catalog after award of Contract to any government agency upon request. Any additions or updates to Current Published Price List and/or Catalog shall be furnished as soon as available to the County of Rockland and all other government agencies that have been furnished a copy of the original price list.
- 3.2. Percentage discount shall remain firm throughout the Contract period.
- 3.3. Vendors shall be able to provide products within (21) days of receipt of order.

**4. PRICE**

- 4.1. Bid prices shall be in a form of a percent discount off prices from the manufacturers Current Published Price List and/or Catalog price. Such discounts as quoted shall apply to all unit levels such as each; case, dozen, gross, etc. as shown in the manufacturers current Published Price List and/or Catalog. Bid prices shall be provided for Inside Delivery on a F.O.B. Empire State Purchasing Group area basis; to any location within Dutchess County, Putnam County, Westchester County, Rockland County, Orange County and Ulster County, New York.
- 4.2. The Bidder shall provide the County of Rockland with one (1) copy of the Bidder's Current Published Price List and/or current year Catalog with their bid and updates as they become available. Failure to provide one (1) Current Published Price List and/or current Catalog with the Bid may deem the bid non-responsive. Price lists may be submitted in a digital format on a CD-ROM.
- 4.3. Successful bidders shall be required to notify the Rockland County Purchasing Division of any revisions to catalogs and to supply updated catalogs or price lists.
- 4.4. Price increases listed in new catalogs shall be allowed only after updated catalogs or price lists have been provided to the Rockland County Purchasing Division.
- 4.5. Bidder shall offer current promotional sales pricing, when the promotional sale pricing is lower than the percentage-off discount awarded under this contract.
- 4.6. All discounts bid must include freight/shipping. There shall be no additional allowance for freight/shipping.

**5. BILLING PROCEDURE**

Any alterations to this document made by the Offeror may be grounds for rejection of the proposal, cancellation of any subsequent award, or any legal remedies available to the County of Rockland.

5.1. All invoices for items sold to any authorized agency as a result of this contract must provide the following information: Purchaser Order #, Quantity, Description of Item Purchased, Stock or Catalog #, Manufacturers List or Catalog Price, Discount, Net Price per item and total price per invoice. ALL INVOICES MUST CONTAIN THE PURCHASE ORDER NUMBER.

**6. WARRANTY**

- 6.1. All warranties from the manufacturer shall apply. Bidder shall, as part of its bid furnish its warranty/guarantee for all goods/services to be furnished hereunder. As a minimum, Bidder shall warrant all goods for a period of one year from date of acceptance. Bidder shall be obligated to repair or replace all defects in material or workmanship which are discovered or exist during said period. All labor, parts and transportation shall be at Bidder’s expense.
- 6.2. The bidder shall be able to perform warranty service or have access to a manufacture warranty facility that can service all government agencies participating in this bid.
- 6.3. Bidders shall provide the name and address of the warranty facility for each manufacturer/brand that they bid on.

**7. REPORT OF PURCHASES**

7.1. The Contractor must, upon request, provide the Rockland County Purchasing Division with detailed information showing products (with pricing) delivered to any and all agencies under this contract. This includes deliveries to not only the County of Rockland but any other municipality or agency which orders from this contract.

**8. AWARD OF CONTRACT**

- 8.1. Bid will be awarded line by line, to the responsible/responsive Bidders who offer the highest percent discount off of each manufacturer’s price list or catalog.
- 8.2. It is the intent of the County of Rockland to make multiple awards (for all brands listed) on this Bid due to requirements of various local government agencies.
