SPECIFICATIONS

1. SCOPE

- 1.1. The County of Rockland Purchasing Division is requesting pre-qualification submissions from Retail Energy Supply Companies for the provision of Electricity and Natural Gas services. This request will allow the County of Rockland along with our Energy Consultant Noresco, LLC to review the qualifications of firms prior to the issuance of a formal bid. The County of Rockland will issue a bid through an invite-only process to those firms who have pre-qualified through this process.
- 1.2. This pre-qualification process is being conducted in accordance with General Municipal Law, Section 103.15.
- 1.3. The County of Rockland has three (3) contracts in place for Firm Electricity set to expire October 31, 2023, Interruptible Natural Gas set to expire December 31, 2023, and Firm Natural Gas set to expire June 30, 2024. The Retail Energy Supply Companies must submit qualifications for the provision of electricity, natural gas or both services.
- 1.4. Due to the volatility in the market the County of Rockland and the County's Energy Consultant have determined it is in the best interest of the County to pre-qualify firms to expedite the bid award selection process.

2. ENERGY CONSULTANT OF RECORD

2.1. The County and participating agencies have appointed NORESCO LLC as its exclusive Energy Consultant of Record for the electricity and natural gas purchases.

- 3.1. The Retail Energy Supply Company must provide information for the County and the County's Consultant to review to determine the qualifications to provide service(s) for the County of Rockland, and participating agencies.
- 3.2. The Retail Energy Supply Company must submit a complete comprehensive summary with company information including:
 - 3.2.1. Overall company description; narrative
 - 3.2.2. Number of years in service
 - 3.2.3. Corporate/company structure
 - 3.2.4. Description of company ownership
 - 3.2.5. Headquarters location
 - 3.2.6. Number of years providing services to New York based customers.
 - 3.2.7. New York State License registered with New York Public Service Commission
 - 3.2.8. Any additional information that would distinguish your firm in its service to the participating agencies.

- 3.2.9. Financial strength of the Retail Energy Supply Companies and their ability procure the volume of energy required to fulfill the county's needs.
- 3.2.10. Litigation history, if any, of the Retail Energy Supply Company for the past three years.
- 3.3. Provide a description of billing-related capabilities, in the availability of the following:
 - 3.3.1. Consolidating billing (UCB)
 - 3.3.2. Summary billing

 - 3.6.1. The County of Rockland has multiple accounts servicing several locations throughout the County.
 - 3.6.2. Current Contracts also include a Cooperative which includes service to Rockland Community College, Rockland County Solid Waste Management Authority and the Rockland County Sewer District No. 1.
- 3.7. A minimum of two (2) references providing similar services to municipalities, commercial and/or industrial load accounts.
 - 3.7.1. The references must include the municipality name and complete contact information.
 - 3.7.2. New York specific experience;
 - 3.7.2.1. Number of years serving customers in New York
 - 3.7.2.2. Description of resources available to serve customers in this region
- 3.8. The County and its Energy Consultant may make such investigations it deems necessary to determine the ability of the Retail Energy Supply Companies to provide services. Qualified Retail Energy Supply Companies must furnish additional information if requested to the County within five (5) days of request, all relevant information and data that may be deemed required to qualify a firm.

4. **CONTRACT TERM**

- 4.1. Upon qualification approval the Retail Energy Supply Company will remain on the County's prequalified list for a term of one year from the date of approval.
- 4.2. The County and the Retail Energy Supply Company have ability to renew the qualification approval on mutual terms for up to two additional one-year terms with an update of information required at the time of renewal.

5. QUALIFICATION APPROVAL

- 5.1. The County and its Consultant reserve the right to reject the Retail Energy Supply Company if it is deemed that the Company is not qualified to provide services to the County of Rockland and participating agencies.
- 5.2. A firm may be deemed unqualified if all above referenced requirements are not submitted for review or additional information furnish within five (5) days of request.
