SPECIFICATIONS

1. SCOPE

1.1. The County of Rockland is requesting prices to furnish and deliver red dyed Ultra Low Sulfur Diesel (ULSD) Fuel and Kerosene for Off Road generator use. Current requirements are for approximately 45 to 50 County delivery sites located within the County of Rockland, utilizing approximately 15,000 to 20,000 gallons annually. Exact locations and tank sizes will be supplied upon award.

2. GENERAL REQUIREMENTS

- 2.1. Prices quoted shall be net prices on delivered product-ULSD red dyed for off road use, kerosene and winter additive. There will be no extra charges for delivery or any fees or surcharges, unless mandated by law.
- 2.2. Contract period shall be for Twelve (12) months commencing on the date of award with the option to extend the agreement for up to three (3) one-year options at the same contract pricing (or lower), terms and conditions, as set forth in the original bid and resulting award, upon mutual consent, in writing.

3. METHOD OF BIDDING

- 3.1. Within this document the bidding structure requests delivered prices for different volume deliveries. Bidders will provide a constant price differential for each delivery range.
- 3.2. Bidders must quote a constant differential to be applied to the average daily rack price for ULS Diesel Dyed and Kerosene posted on the Newburgh New York Terminal, simple average of high and low, for Global Petroleum, Sunoco, Buckey and Mirabito, carry four places, where applicable, do not round off.
- 3.3. Use Friday, June 30, 2023, price. Your quoted differential will be added or subtracted from this figure.
- 3.4. Future increases and/or decreases of unit price bid during this contract will be governed by changes in the base price as described in §3.2 above on a weekly basis in the following manor.
- 3.5. Throughout the term of the contract, the County of Rockland Purchaser, or his designee at the County of Rockland, Department of Purchasing, shall be notified by e-mail or fax, of the weekly price as it appears on each and every Friday. Price will hold for one week (Monday through Sunday) until the following Friday change. If there is no Friday posting, the next day specified prices are published will be utilized. If no posting is available for Friday due to a holiday or any other reason, the closest previous day's posting will be utilized until the following week's normal Friday change.
- 3.6. In the event that the category chosen (Newburgh, NY ULSD Dyed and Kerosene) is not posted for a week or longer, the awarded supplier and County of Rockland may choose to agree to another category for the period of time the Newburgh, NY posting is not published.
- 3.7. The County reserves the right to calculate price changes on a daily basis if the market becomes so volatile that it is deemed in the best interest of both parties to do.
- 3.8. Federally tax-exempt fuel may be dyed red using solvent red dye 164. This bid is for ULSD fuel with red dye. This must be included in bidder's price.

4. DELIVERY REQUIREMENTS

Any alterations to this document made by the Offeror may be grounds for rejection of the proposal, cancellation of any subsequent award, or any other legal remedies available to the County of Rockland.

5. BIDDER REQUIREMENTS

- 5.1. Bidder must be a business where the primary function is to provide fuel.
- 5.2. Bidder will provide segregated storage and delivery transports for delivery of the product.
- 5.3. Bidder will provide adequate spare delivery equipment to ensure delivery of product.
- 5.4. Bidders' delivery trucks will be equipped with meters to accurately measure quantities delivered. Metered deliveries must be accompanied by a delivery ticket showing brand or grade and number of gallons delivered.
- 5.5. Bidder will store a minimum of thirty days of inventory to ensure sufficient product availability, especially in the event of natural disasters, or other emergencies where fuel supplies become scarce.
- 5.6. Bidder will have a primary storage terminal within 50 miles radius of the delivery locations to insure timely deliveries in inclement weather and during emergencies.
- 5.7. Bidder will provide a copy of its Quality Control Program to ensure product integrity and immediately provide upon request, test results for lubricity and other product specifications.

6. PRODUCT REQUIREMENTS

6.1. Fuel Products offered under this bid shall conform to industry standards as specified in the current NYS contract and ASTM standards for the appropriate product.

7. GUARANTEE

7.1. The bidder guarantees to furnish adequate protection from damage to agency's buildings, grounds and or equipment occurring on account of or in connection with, or occasioned by, or resulting from the furnishing and delivering of diesel engine fuel under the contract and shall be liable for any damages for which he/she or his/her employees are responsible.

- 7.2. This liability includes but is not limited to oil spills occurring during delivery. The contractor shall provide constant surveillance during delivery by having a person in attendance at all times at point of transfer. Oil spills shall be immediately reported to the agency business office to effect contact with a representative of the NYS Department of Environmental Conversation.
- 7.3. A call can be placed twenty-four hours a day at the New York State Oil Spill Hotline **1-800-457-7362**.

8. WINTER MIX BLENDED DIESEL FUEL

- 8.1. To aid in preventing any problems in performance of fuel delivered during the winter months, the awarded vendor will be required to deliver fuel mixed, prior to delivery.
- 8.2. It shall be the contractor's responsibility to satisfy the end users requirements by furnishing blended product when called for. When billing for blended products, invoices will include current contract adder for each grade, type of mixture furnished and computation of total price.
- 8.3. All fuel delivered which contains combinations of 1D/2D or winterizing additives shall be blended at the bulk plant, or via a dual/multiple manifolds on the truck which mixes them for simultaneous delivery. Deliveries via a non-manifold type of truck should not be accepted.

9. SAFETY DATA SHEETS

9.1. Bidders must submit Safety Data Sheets (SDS) on all applicable products upon request.

10. PREVAILING WAGE

- 10.1. Fuel Delivery service is subject to Article 9 Prevailing Wage Rates.
