The County of Rockland is seeking a contractor to supply all labor, materials and equipment to clean ductwork at the Grogan Correctional Center for the kitchen and dryer exhaust systems. Service will be required upon award with the option to request additional cleanings if required within one year.

1. SCOPE OF WORK

- 1.1. Cleaning of Dryer exhaust system including exhaust fans
 - 1.1.1. Exhaust ducts shall be cleaned and scraped where possible, using an industrial cleaning solvent.
 - 1.1.2. Filters shall be removed, cleaned, and replaced where possible.
 - 1.1.3. Exhaust fan covers shall be removed. Fan motor and all compartments will be cleaned using cleaning solvents and compressed air.
 - 1.1.4. Front vents on hoods shall be removed and cleaned.
 - 1.1.5. Interior of dryers shall be cleaned in lint compartments.
 - 1.1.6. Protection of all areas where work is being performed shall be provided, as well as cleanup upon completion.
- 1.2. Cleaning of Kitchen exhaust system including backboards, hoods, drip pans, filters, and exhaust fans
 - 1.2.1. All surfaces shall be cleaned using degreaser.
 - 1.2.2. Backboard and hood shall be polished using a commercial polish.
 - 1.2.3. Exhaust duct shall be cleaned and scraped where possible using an industrial cleaning solvent.
 - 1.2.4. Filters shall be removed and soaked in hot water with a degreaser, cleaned and reinstalled.
 - 1.2.5. Exhaust fan covers shall be removed, Fan motor and all compartments shall be cleaned using cleaning solvents and compressed air.
 - 1.2.6. Certification stickers shall be placed on all hoods upon completion of service. Date of cleaning and next scheduled cleaning shall be clearly identified.
 - 1.2.7. Protection of all areas where work is being performed shall be provided, as well as cleanup upon completion.
- 1.3. All dryer system work shall be performed after 3:00 PM Monday-Friday. All kitchen work shall be performed after 6:00 PM Monday-Friday.
